

- (1) Description of object: round, color white, size impossible to judge due to darkness, resembled moving ball of fire, left white flowing trail. Method of propulsion unknown. Only sound heard was a whirperack at initial appearance, and a whistling sound as one object passed directly overhead later. Objects moved faster than any known jet aircraft.
- (2) This was approximately 2230 hours 11 August 1952. Objects appeared at regular 3-minute intervals, headed due west, and puffed out. At one time two objects appeared at once, crossed paths, and disappeared. At another time, four appeared, all traveling in a straight line due west. The objects seemed to materialize directly overhead.
- (3) Manner of observation: Naked eye. Altitude could not be judged.
- (4) Location of observers: Standing on road at 905 Jefferson St, Lake Charles, La. Coordinates 29° 30'N, 93° 30'W. Location of object with respect to observers: straight up, then moved due west. Distance from observers could not be judged.
- (5) Identifying information of observers: [REDACTED] (brothers), [REDACTED] Ages 17, 15, and 14, respectively.
- (6) Weather and winds aloft conditions at time of sighting: slightly cloudy, no wind.
- (7) To the knowledge of the observers, there was no activity or condition, meteorological or otherwise, which might account for the sighting.
- (8) There is no existence of any physical evidence such as fragments, photographs and the like, of the sighting.
- (9) No interception or identification action taken.
- (10) At time of sighting, observers viewed one airplane, very large, heading from southwest to northeast until the night lights disappeared from sight. A short time later, another appeared, heading due west. Sighting of objects began at aprx 2230 hrs and continued for approximately 1½ hours.
