

### PREFATORY NOTE

This List is printed as manuscript to meet an immediate call for references on railroad valuation. The subject was found to be so interwoven with that of railroad capitalization that it proved inexpedient to separate the two. The List therefore includes both subjects, with emphasis only on railroad valuation. The material scattered through the various state reports is of increasing importance in the issues for the more recent years. No attempt, however, has been made to index it in detail. A few works on the economics of railroad construction have been included because of their relation to the subject.
