**The pamphlet is mailed only to registered voters whose names have been furnished to the secretary of state by the county clerks of the several counties.**

The official ballots for the several counties containing a complete list of the names of all candidates for the various state, district and local offices are prepared and printed by the respective county clerks, who also assign the candidates' ballot numbers.

## RALPH H. CAKE

Republican, Candidate for National Committeeman

## HENRY BLACK

McCormick of the Chicago Tribune for Secretary of State; Beardsley Ruml for Secretary of the Treasury; General Douglas A. MacArthur, Secretary of War; Senator Burton K. Wheeler for Attorney General; Sewell L. Avery of Montgomery Ward and Co. for Postmaster General; General John L. must be settled by arbitration. A job for every returned soldier through co-operation with business instead of Government dole.

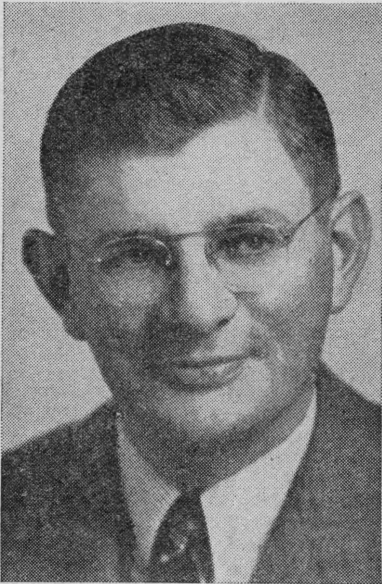

In offering my name as a candidate for election as a Delegate to the Republican National Convention, from the State at Large I do so with the thought that many Oregon Republican voters favor potential candidates for the Republican Presidential Nomination who are not making any campaign in Oregon, and whose names apparently will not appear on our ballot. 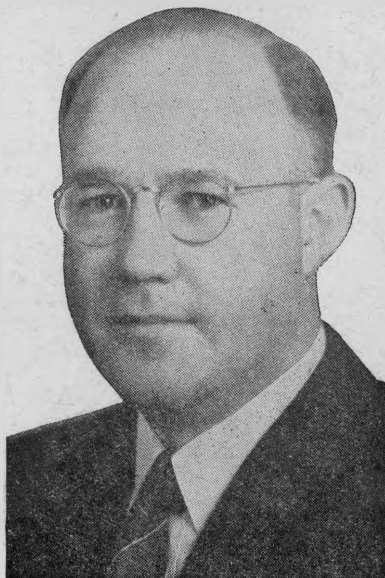

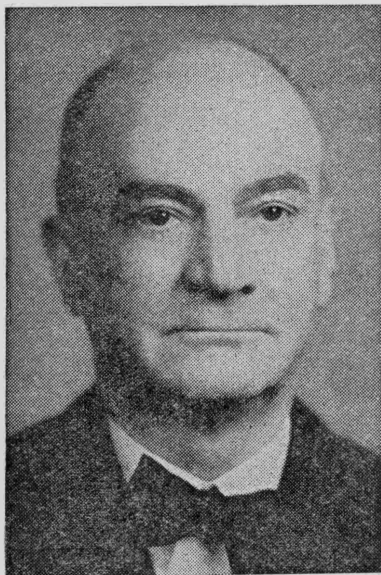

**CUSTER E. ROSS****Republican, Candidate for Delegate at Large to the National Convention**

I am a candidate for election as Delegate to the Republican National Convention to be held at Chicago, Illinois. In solicitation of your support, I make the following statement:

A decided change in the administration is absolutely necessary if the Republic is to continue in the spirit of its Founders. Mr. Roosevelt and his "new dealers" are putting aside the ideals of the Republic; they do not believe that all men are created free and equal; they have set up classes among the people and have sought to set class against class for purely political purposes; enormous amounts of the tax payments of all the people have been used for political propaganda and to secure the election of them and of their ilk. A cruel dictatorship, in the guise of democracy, has been set over the people, and they are needlessly persecuted by countless bureaus, commissions, officers, agents and investigators. Incompetents, and worse, hold the offices and exact their double tithes alike from laborers, farmers, small business and all others. Their motto, as shown by their

words, is "Tax and tax, spend and spend, elect and elect." That must be changed if we are to survive as a free people.

We must, of course, win this war whatever may be the cost. It is beside the point to debate about who is responsible for our being at war; we are in it, and must prevail or perish. The fighting is now being done by our brave youths but is directed, in many instances, by incompetents and bunglers who hold their positions as political or personal favorites of Mr. Roosevelt. No war can be won without competent leadership.

I personally favor the nomination and election of Gen. Douglas MacArthur to the Presidency. He has had little help from the present administration, yet he has accomplished much; he is a brave soldier, an able commander and a first-class administrator; he will eject the politicians and incompetents from their commands. If he is not available, then Gov. Dewey, a very competent man would be my choice. Gov. Bricker, Gov. Saltonstall, Gov. Warren, and many others would be excellent chief executives. I do not favor Mr. Willkie. I fear that his promises to the people again might well be mere "campaign oratory".

I was born near Silverton, Oregon, March 10, 1883, and live and practice law at Salem, Oregon. I am married. We have three children; both our boys and our son-in-law are in the armed forces.

In 1942 was elected President of the International Baby Chick Association, largest poultry organization in the world.

I will work for and support a Republican platform that pledges to the American people:

1. Our united all out efforts to win the war as soon as possible.
2. Full recognition of our responsibility to the men and women of our armed forces.
3. International cooperation to prevent future wars.
4. Unrestricted production by agriculture, labor and industry. An economy of plenty instead of scarcity.

If you will write to me I will send you a copy of the Political Advertiser and Soldiers' Gazette containing my views on national, state and local issues.

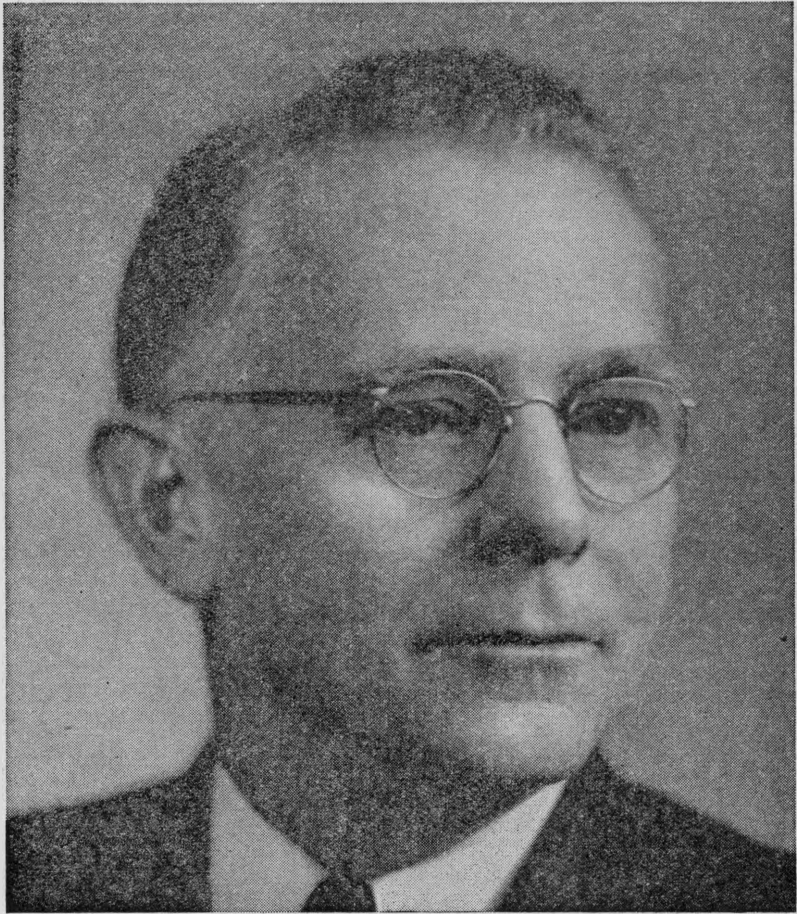

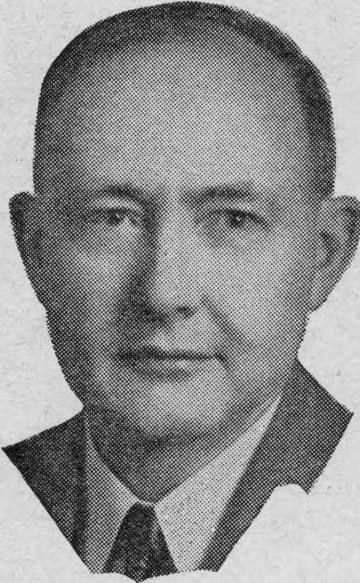

In 1929 Sprague became principal owner of *The Statesman* at Salem and has served as its editor and manager from 1929 to date, except during his term as governor.

Besides his newspaper work Sprague has been active in civic affairs. He is President of the Oregon War Chest which raised over \$1,000,000, for war agencies in 1943; is vice chairman of the Marion County War Bond Committee. He is a member of the board of directors of the National War Fund; and of the Salem Community Chest, the Y. M. C. A., the Salvation Army, and of the boards of trustees of Willamette University and Lewis and Clark College.

The Sprague home in Salem is known for its hospitality and friendly atmosphere. Mrs. Sprague is a native of Umatilla County, Oregon, and like her husband takes part in many activities. She is a past state president of P. E. O., is regent of Chemeketa Chapter, D. A. R., and is a member of the General Council of the Presbyterian Church in the U. S. A. The Spragues have two children: Martha, whose husband, Dr. Melvin T. Hurley, is a lieutenant serving in the medical corps of the navy; and Lieutenant Wallace A. Sprague, USNR, on duty since May 1, 1941.

Mr. Sprague is a loyal Republican who has pointed the way for the return of the Republican party to power. In 1934 in a noteworthy address at the state convention of Republican Clubs he challenged the philosophy of new deal centralization of power. In this and other states he has made political addresses to outline party policy. At the invitation of the Republican National Committee in 1940 Sprague spoke in nine western states in behalf of the Willkie-McNary ticket. At the Governors' Conference in Boston in 1941 he gave a warning of national significance on the Japanese threat in the Pacific.
