



2. This office appreciates the view expressed in reference 1a above that recommendations of the Far East Command will be considered when the modification or augmentation of Table of Organization and Equipment 30-600 is again considered.

3. It is felt certain that test by any of the major commands will support our contentions, previously cited, that the current Table of Organization and Equipment does not yet cover, both in personnel and equipment, the vital practical fields of reproduction and dissemination of intelligence data, research and production of geographic studies, and liaison; however, these problems are not peculiar to this theater. ATIS had a reproduction section throughout the Pacific campaign equipped as it is now and was responsible for printing or duplicating for dissemination all essential

intelligence material originating in ATIS. Throughout the occupation of Japan, ATIS production workload has not materially changed. During the month of December 1948 alone, 11,044 publications were bound and distributed (see Incl 1 for detailed breakdown). This figure is the result of the appreciation of the vital nature of these publications by the Department of the Army and interested agencies and of the constant demand for widespread dissemination (see reference lc above). In this connection, historical data contained in reference ld above bears out the soundness of our recommendations. Throughout the Pacific campaign, the ATIS reproduction section moved, from small beginnings, through a strength of four officer and 65 enlisted personnel in September 1944 to six officers and 107 enlisted personnel in September 1945. By September 1945, ATIS had reproduced approximately 17,781,000 pages of intelligence data (see Incl 2 for detailed breakdown). Our recommendations for the types of teams to staff this production section were based upon the experience gained by this organization under conditions of war and occupation.

4. Further, the need for separate teams specializing in the collection of geographical information and capable of preparing terrain reports and estimates for planning and tactical purposes is evident from a study of the accomplishments of the war-tested Allied Geographical Section (reference paragraph lc above). This section has become the Geographical Section, G-2, GHQ, and has carried on the mission of topographic intelligence during the occupation. One month's production, December 1948, of 1,109 pages of terrain intelligence compiled is indicative of the tremendous workload still assigned this section (see Incl 1 for detailed breakdown). During the Pacific campaign, the Allied Geographical Section produced and distributed, by 15 September 1945, 193,555 topographical intelligence reports.

5. The current trend is towards even further expansion of intelligence dissemination. This is evidenced by a recent request from the Department of the Army for an increase in distribution of the Periodical Summary, CIS, FEC, and the Intelligence Summary, FEC, to the Intelligence Division, GSUSA (reference paragraph lf above).

6. Your suggestion for a request for special issue of reproduction equipment to Logistics Division, Department of the Army, as suggested in paragraph 3, reference lb above, is appreciated but is not deemed necessary at this time. Equipment to accomplish the present mission of this section has been obtained from Far East Command Tables of Allowances supplemented by local special purchases. This equipment, plus support furnished from other services and commercial printers, performs the reproduction required under present conditions. Our correspondence was not a plea for immediate equipment but a long-range recommendation for the benefit of the service to insure that reproduction equipment and necessary personnel as previously recommended are provided for in authorized Table of Organization and Equipment 30-600, so that the practical lessons learned during World War II will not be lost administratively in the event of future global conflict.

If, prior to modification or augmentation of Table of Organization and Equipment 30-600, its application should become mandatory, it will be necessary to augment from the bulk allotment of personnel and equipment, the Military Intelligence Service unit activated here, in order to provide the services now required by this Section: for example, Intelligence Division has placed top priority (See Intelligence Division letter, file MID 906, subject: "Intelligence Coverage in Soviet Dominated Areas in the Far East", dated 3 October 1946, and Intelligence Division letter, file MID 906, subject: "Intelligence Coverage in Soviet Dominated Areas in the Far East", dated 10 January 1947) on information on Soviet-controlled areas. At this moment, our interrogation service (Allied Translator and Interpreter Section) secures geographical, industrial and military data from thousands of repatriate prisoners of war and condenses them (publications) in reports and geographic studies.





2. Reference 1a above presented the plea that the dissemination of intelligence requires reproduction facilities, draftsmen, typists and a unit for publication. These requirements cannot be over-emphasized. "Dissemination" is synonymous with publication in multiple copies.

3. Paragraph 3, Section I, Reference 1b above outlines the capabilities of Military Intelligence Service Units organized under T/O & E 30-600. It specifically states "non-linguist operational teams are capable of producing collated information for intelligence". This statement is unrealistic. A military intelligence service unit organized under T/O & E 30-600, as it now stands, is not capable of "producing intelligence within itself". Neither the personnel nor equipment required for adequate "reproduction and dissemination" are provided. During the recent Pacific War, the great distances separating headquarters from field units, rear echelons from advance echelons, supply points and service units from combat troops dictated that each echelon be self-sufficient. Future war plans recognize that identical conditions may again exist.

4. T/O & E 30-600 being of cellular type, should be flexible to permit adaptation to all conditions of war and peace in theaters or geographical areas in which conditions are of widely varying character. It should incorporate all such cells that are needed but not provided in other T/O & E's to meet these requirements. T/O & E 30-600 may be suited for operations in other parts of the world but it does not provide the cells necessary for operations in Far East Command, based on our war experience.

5. Inclosure 1 lists intelligence reports and relative data required by and furnished Department of the Army by Assistant Chief of Staff, G-2, Far East Command. In addition, certain reports of a top secret classification

and special reports are forwarded to Department of the Army on the same basis as those listed in Inclosure 1. It is obvious that such a tremendous volume of vital information could not be developed without adequate personnel and reproduction equipment to accomplish their publication. Reproduction agencies in Far East Command, like Engineer Section, that have such facilities also have their own priorities and can offer us only partial reproduction support. The achievement of comprehensive dissemination remains the classical responsibility of G-2. Despite Department of the Army requests for increased distribution of our intelligence reports, Department of the Army has so far failed to provide us in T/O & E 30-600 the tools we require to accede to its requests. Were G-2, Far East Command, to organize units involved in the collection and dissemination of intelligence under T/O & E 30-600, reports as outlined in Inclosure 1 would not be available in the necessary amounts and the timeliness of such reports would consequently suffer.

6. It is requested that production teams as recommended on pages 126 and 139 of the Proposed Table of Organization and Equipment, Translator and Interpreter Service (war time), be carefully scrutinized and provision for those or similar teams be made so that comprehensive intelligence coverage of Soviet dominated areas will not be jeopardized by inadequate dissemination.
