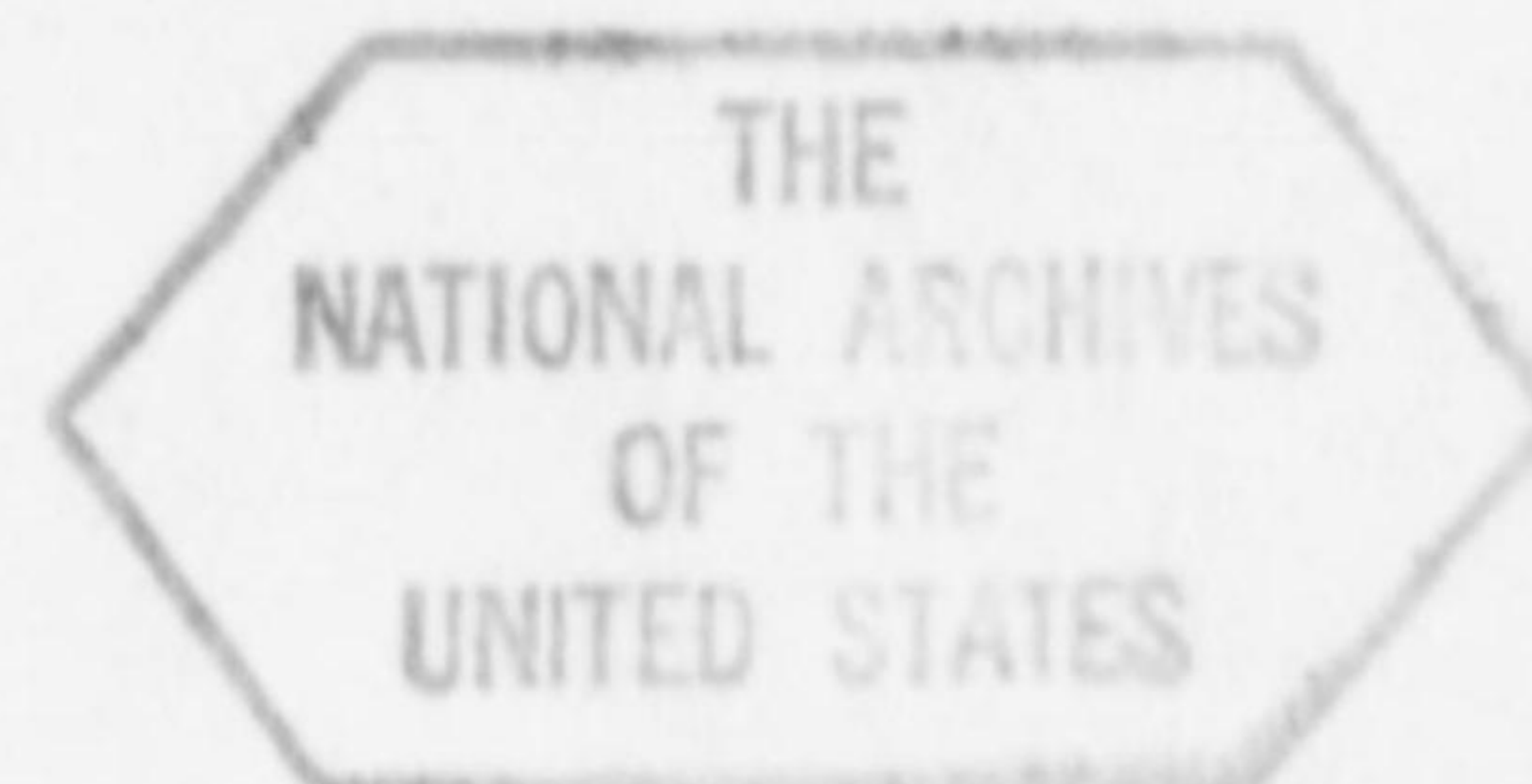

SUBJECT: Per Diem for TDY Travel

TO: Chiefs all Regions

1. Regions will pay the per diem for TDY Travel for assigned Officers and Enlisted Men as authorized by Circular 25, GHQ, FEC dated 30 May 1951 and in accordance with the following <sup>limitations</sup> directives.

05T  
2. TDY Travel performed in Special RR Cars will not be considered Government quarters but messing facilities are available. The certificate required by par 7 will be included in the order authorizing TDY Travel for all TDY trips in Special RR cars. Per Diem authorized: Officers - \$4.20 and Enlisted Men - \$2.75 per day.

3. Officers and EM on TDY at camps using indigenous hotels for billets and with messing facilities available will receive Per Diem of \$4.20 for officers and \$2.75 for EM.

4. Officers and EM on TDY at camps using PD houses and with messing facilities available will receive Per Diem of \$1.80 for officers and \$.75 for enlisted men.

5. For officers and enlisted men on TDY at camps and attached to another Military Unit for quarters and/or rations, no per diem is authorized.

1. Authority is requested to cut corrected orders in the case of Mr. Shalfeieff and place him on the type voucher issued for foreign nationals (FEC, AGO Form 85) in order that this individual may receive travel (per diem) allowances which, as of today, he has not been paid.

2. Reference is made to the following letter, Subj: "Administration of Foreign Nationals", dated 13 August 1947, addressed to the principle General Headquarters in the Far East Command (AG 230) (13 August 47) GA) and with special reference to paragraph 11, sub-paragraph b (1) and (2).

3. The foregoing reference particularly paragraph 11 b (1) and (2), has been rescinded by TWX SCAP (ZX 41152), a copy of which was mailed to this headquarters and received 23 March 1951.

4. When notified by telephone of the change, no copy of the basic letter regarding the administration of foreign nationals could be found in the files of this headquarters. There is no individual presently on duty with this Civil Affairs Region who was with this headquarters in 1947 (with the exception of a few indigenous personnel), nor did any one have any recollection of such a directive. Why there was no copy of the directive available, I do not know.

5. It so happens that Mr. Shalfeieff has made no field trips except on orders cut for Americans and which travel orders state "No per diem authorized". Therefore, in justice to Mr. Shalfeieff, it is requested that the authority asked in paragraph 1 be granted, or that this headquarters be advised as to what may be done in this case.
