

### **Creative Commons**

 Non-profit organization dedicated to promoting better sharing of culture and knowledge in the public interest.

• Licences and public domain tools

 An international network of lawyers, activists, and experts in copyright law, open education, culture, science, etc.











Access and sharing of heritage are essential to sustain vibrant and thriving societies.

Cultural heritage institutions are **gateways**— **not gatekeepers**: pivotal points between heritage and the public.

Preserving and sharing heritage is at the heart of their **mission**.

This mission is important now more than ever, as climate change, global health crises, and violent conflicts are posing some of the greatest threats to heritage and the institutions that hold it.

# What are the barriers to open culture? Here's what the CC community has to say

What are the barriers to open culture? What challenges do cultural heritage institutions — such as galleries, libraries, archives, and museums (GLAMs) — face in making their collections openly accessible online? How could Creative Commons support institutions in addressing these challenges and taking part in better sharing of cultural heritage?

In search of answers, we looked at past research, notably Andrea Wallace's Barriers to Open Access-Open GLAM, and asked more than 30 experts in the open culture movement. You can watch what they told us in our CC Open Culture VOICE's Voice series. Here's a small sample of what we heard:

"A number of imbalances related to power, priority, interests, and resources can facilitate or impede participation in digitization and open access initiatives..." — Andrea Wallace

"...we need to consider what openness online really means and who the audiences are. Are they mostly privileged audiences? Are they mostly people who have access to very expensive laptops and mobile phones? Or is this truly an open culture that can be accessed anywhere, anytime by all people around the world?" — Temi Odumosu


"Another perceived barrier is that [GLAMs] are missing out on opportunities to generate income from the collections." — Dafydd Tudur

"Open GLAM requires resources, expertise, and investment in rights management and copyright, which are complex." — Douglas McCarthy

# Legal framework & Creative Commons licenses


- Works of original creativity are protected by copyright.
- Copyright is granted to creators of works automatically upon creation; no registration or other formality required.
- This means that by default, a work is always published "all rights reserved."
- With Creative Commons, we can go to some/no rights reserved

### **Creative Commons licenses**

CC licenses and public domain tools enable creators to offer more legal permissions than traditional copyright, given the increased flexibility and freedom of the internet.





# Legal and ethical issues related to traditional cultural expressions

GLAMs have a range of **responsibilities and duties** in respect of Indigenous cultural heritage, particularly in light of questions around **restitution/repatriation** and of **sensitivities** around heritage linked to communities.

There might be instances where **digitizing** cultural heritage material and **making it available** openly is **unacceptable** practice, particularly in situations of power imbalance, for instance as regards <u>Indigenous</u> cultural material or material held in cultural institutions as a consequence of colonization, such as <u>African</u> cultural heritage.

Open culture is not only about sharing cultural heritage by respecting copyright law, but also how to do it **more responsibly, collaboratively, and equitably**.
