I, Tomiji MURAYAMA, a physician in Tokyo, Japan, was family or house physician for the late Baron Kumao HARADA from 1922 until his death in 1946.

During the period from 1922 until 1941 I attended the late Baron HARADA during severall illnesses, none of which were serious, and at no time was there a loss of memory or any sickness which would impair his mentality.

During the period 1930 until 1941 the late Baron HARADA was in complete command of all his faculties and was alert mentally.
