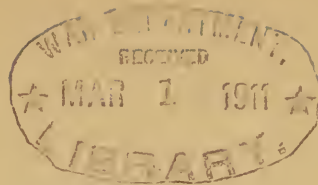

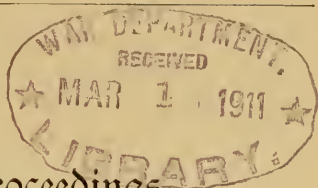

Convention Proceedings.

The Ninth Annual Convention of the Woman's Relief Corps, Department of Kansas, Auxiliary to the Grand Army of the Republic, met in regular session in the Methodist Episcopal church in the city of Pittsburg, Tuesday, February 21st, 1893, at 9:30 o'clock a. m., and was called to order by the Department President, Mrs. Ida Wilson Moore.

All united in singing the opening ode, led by Mrs. Belle C. Harris. Prayer was offered by Department Chaplain Mrs. Mary K. Holland.

The Conductors reported all present in possession of the proper password.

The Department President then declared the Convention

formally open for the transaction of such business as might properly come before it.

The Department President then announced the following committees:

The National President, Mrs. Margaret Ray Wickins, and a part of her staff were then formally introduced to the Convention.

The Department Officers were then invited to the platform and introduced to the Convention.

The Department President then called the attention of the Convention to the historic gavel stand which had been kindly furnished for the use of the Convention by Dr. Taylor, of Pittsburg. This stand is a section of a tree from the battle-field of Chickamauga and literally filled with bullets, shot and shells—sad reminders of that fearful and memorable battle. In response to a request that all present having either father, husband, son or brother in that battle should rise, thirty-three ladies arose.

On motion of Mrs. Julia A. Chase, a unanimous vote of thanks was extended to Dr. Taylor for the use of this historic relic.

The Committee on Credentials made the following report:

We find from the election returns received from the Corps of this Department, the whole number entitled to vote at this Ninth Annual Convention to be 970; of which 173 are reported present at this opening session and have been furnished the Delegates' badges which have been presented for this purpose by Gen. Russell Corps, No. 98, of Pittsburg.

The Convention was then declared open for the reception of comrades and other visitors to listen to the reading of the reports of the Department Officers.

A large delegation of comrades of the Grand Army was announced in waiting. They were admitted and Commander Greene escorted to the platform and the comrades seated.

Mrs. Edith M. Wood, of Pittsburg, then delivered an address of welcome as follows:

"Mrs. President and Members of the Ninth Annual Convention:

"As I come before you today to extend to you a welcome from Gen. Russell Corps No. 98 as their representative, and from the citizens of Pittsburg, I feel a justifiable pride in saying that I am bidding welcome to the grandest and noblest organization in existence. As the time drew near for the annual meeting of the Woman's Relief Corps it was with a feeling of pride that the Corps whose duty it is to act the part of hostess, looked forward to the event with much pleasure.

"And as to me has been assigned the pleasant task of extending this welcome, I wish you to know how heartily we appreciate the honor conferred upon us, and how gladly we welcome you to our midst. We are very desirous of making your visit to our Smoky City one never to be forgotten, full of pleasant memories, so that when you depart from us you will wish to return.

"Our industries consist of six zinc smelters, a silver smelter, implement factory, machine shops, planing mill, numerous coal shafts, and a vitrified brick plant, where the brick is made with which our streets are paved.

"It is the earnest desire of all our citizens, that whatever

time you can spare from the business of this Convention should be spent in viewing these many places of interest. The doors to our manufactories and coal shafts are always open to visitors; and there you will find a welcome for the operators are always ready to show and explain the different processes of the manufactory.

"There have been a number of Grand Lodges in session in this city in the past year but I can assure you none have come with a more hearty welcome than the 'Boys in Blue' and Woman's Relief Corps.

"Pittsburg feels honored for never before has she had the opportunity of welcoming the saviors of our noble country.

"Never have the loyal hearted ladies of Pittsburg had the privilege of grasping in a warm handclasp those who pledge themselves to care for the disabled soldier, his widow, or orphans.

"We wish to be better acquainted with you, we open our hearts and homes and bid you enter.

"And again in the name of Fraternity, Charity, and Loyalty, I bid you a hearty welcome."

The Department President responded as follows:

"In behalf of the Ninth Annual Convention of the Womans' Relief Corps, Department of Kansas, I thank you for this hearty welcome. Ever since our entrance into your busy, bustling, prosperous city, we have realized we were among friends.

"And these formal words of welcome touch our hearts deeply, and we wish to assure you we appreciate the kindness shown us by Gen. Russell Corps, No. 98, and the citizens of Pittsburg. We trust we shall gain as much benefit from our Convention as pleasure from this visit. This meeting and the hearty welcome, cordial reception, and royal entertainment accorded us will ever be to us a pleasant memory."

Mrs. Wood then said:

"And now, Mrs. President, I have another pleasant little duty to perform which comes right along in this line.

"Recognizing the fact that, 'The hand that rocks the cradle rules the world,' and that the hand that holds the gavel has

more opportunity, not only to rule the world, but to relieve the distressed, comfort the sick, and watch over the widow and orphan.

"And recognizing in you one of the kind hearted loyal ladies of our noble Order, a lady who has conducted the business of this Department, without jealousy or discord, and one who I believe is beloved by all your associates in the work, as president of Gen. Russell Corps, No. 98, I have the pleasure of presenting to you this gavel. It is composed of several kinds of material. The light colored oak in the head of it is from the limb of a tree which stands on the battlefield of Wilson Creek, the sacred spot where fell the gallant and bravest of brave generals, Nathaniel Lyon."

"This battle-field was the scene of the most desperate fighting of any during the late war. The walnut handle represents the native wood which grows along all fair Kansas' streams. The metal tips are zinc, representative of our own 'Smoky City.' In this you will see the labor of our thousands of wage earners. The inscription designates whence it came and to whom it is presented.

"Altogether it represents the loyalty and good will of the Woman's Relief Corps of Pittsburg.

"Our hearts and best wishes are ever with you and when you have finished this session of the Department Convention. We hope that you will place it among your choicest treasures. May you, Mrs. President, accept it and remember Gen. Russell Corps No. 98 as being loyal to you, loyal to our Order, and loyal to our Nation."

The Department President responded as follows:

Mrs. Wood and Members of Gen. Russell Corps:

"This presentation of this historic gavel is a complete surprise to me, but I thank you most sincerely for this evidence of your good will towards me. I had long looked forward to this visit to Pittsburg and find it a prosperous young city. It is indeed worthy of being called the 'Pittsburg of the West.' This gavel, the head of which is of wood from the the Battle of Wilson Creek, tipped with zinc from your own smelters, beautifully engraved, the handle of our own Kansas wood, walnut,

will ever be to me a most precious souvenir. Again, I thank you."

The annual address of the Department President, and the reports of Senior Vice President, Junior Vice President, Secretary, Treasurer, Chaplain, Counselor, and Inspector were then read and each referred to a committee.

Short addresses were then made by Commander Greene, Capt. J. B. Johnson, Capt. Bernard Kelly, and Comrades Diehl, and A. Johnson, which were received with much applause.

Commander Greene invited the Convention to an open session of the Grand Army to listen to the reports of their officers at 2 o'clock. This invitation was accepted and the Convention adjourned, to meet at 3. p. m.

President's Address.

*To the Officers and Members of the Ninth Annual Convention
Department of Kansas Woman's Relief Corps, Auxiliary to
the Grand Army of the Republic:*

It is a pleasant and auspicious occasion that has brought us down to this young and prosperous city to give an account of our stewardship for the past year, and to legislate for the future. In the name of the Department I bid you welcome.

Since last we met one more year has been added to the history of our Order. While the year that has just past has been a year of responsibilities and much hard work, it has not been devoid of interest and pleasure to those who have been actively engaged in the promotion of the work of our Order which is to-day accomplishing so much to relieve the distress and suffering caused by the War of the Rebellion.

It is not my purpose today to burden this Convention with the details of the work of the past year. The reports of the various officers will be found to contain a summary of the work of the year as performed in their various offices and will be submitted to the careful consideration of this Convention. For my own work I can only say that while I have given to it the greater part of my time and the best of my ability, I am conscious of having accomplished much less than I had hoped when you honored me with this position one year ago. The field is so large, the Corps so numerous, and the demands so frequent that it is an impossible task for the President to personally supervise more than a small fraction of the details of the work. But as I pledged to you one year ago my very best efforts for the work in this Department, so have I faithfully tried to fulfill that pledge.

We have met not only to review the work of the past year but to plan for the coming year; and in our deliberations during

this Convention, may we ever bear in mind the "Good of the Order."

WORK OF THE YEAR.

The Department Secretary will make a very gratifying report of the Corps intrusted to our care.

It has been my aim during the year not only to add new Corps to our roster but to strengthen the weak ones. Our Order has advanced during the year with a good substantial growth. There are now 254 Corps on our roster with a membership of 7357.

I have issued during the year ten General Orders, two Special Orders, and three Circular Letters.

Circular Letter, No. 1, I sent, in December, to the Commander of each Post in the State having no Woman's Relief Corps Auxiliary thereto. Two Corps have already been organized as a result of this letter, and I have reason to believe others will soon follow.

Much time, labor and patience has been given to the immense correspondence incident to the work of this Department. This has occupied no inconsiderable portion of my time.

To all communications I have accorded a ready response, whether they demanded official recognition or not. All answers to communications from Corps members requiring official information have been forwarded to such members through their Corps President.

I have granted numerous Special Dispensations, sent many commissions and details for Corps Instituting and Installing officers.

OFFICIAL VISITS.

It has been a pleasure to respond to the invitations to visit

Corps officially, and when not engaged in other official duties, I have invariably accepted these invitations. Many new friendships have thus been formed which I shall always appreciate, and I trust the Order has received at least some benefit from these visits.

I inspected the Corps at Larned, Salina, Beloit, Scottsville, and Herington. Installed the officers at Abilene, Hutchinson, Herington, Wamego, Manhattan, and Lecompton. Instituted Corps 132 at Industry, and Corps 249 at Lecompton.

During the year there have arisen difficulties which required official action in Corps Nos. 40, 100, and 221.

In each of these Corps the trouble arose from the illegal election of officers. Upon request I visited Corps Nos. 40 and 100 for the purpose of adjusting the difficulties. In both cases the illegality of the election grew out of failure to notify each member of the Corps of the election of officers as required by Rules and Regulations. After due investigation, a new election was ordered and officers elected who had taken no part in the trouble. Both Corps are now working harmoniously and reported as doing well.

The settlement of the difficulty in No. 221, I placed in the hands of Mrs. Lucy R. Jones, Department Junior Vice President. In this Corps two elections had been held, both proving to be illegal. As in both the other cases a new election was ordered and a President elected who had taken no part in the difficulties. The report from Mrs. Jones is that this Corps has bright prospects for the future.

Great credit is due our Department Junior Vice President for the admirable tact and skill displayed in the amicable adjustment of this difficulty. Many minor difficulties have arisen in other Corps in the Department during the year, but fortunately they have always been adjusted by correspondence.

MEMORIAL DAY.

From the Chaplain's report it will be seen that Memorial Day was generally observed throughout the State with appropriate ceremonies.

This beautiful custom of assisting the Grand Army in every possible way in the sacred exercises of "perpetuating the memory of the heroic dead" by bringing our floral offerings as tributes and placing them above the true and the brave "who are bivouaced on the Eternal Camping Ground," is rapidly growing. Each year while it increases the work, as one by one the soldiers are laid to rest to await the reveille from on high, it finds more willing hands to perform it.

Let it be our sacred duty to perpetuate this tender and touching custom.

SPECIAL RELIEF WORK.

The towns of Towanda, Harper, and Wellington were visited last spring by destructive cyclones. The Corps at these places suffered severely; all of them by loss of property and at Towanda the Secretary was killed and the Chaplain injured severely.

Upon learning of these disasters and the great need of these Corps, I at once sent \$35.00 to each from the Department Relief Fund, and issued a Special Order asking the Corps in this Department to contribute to the relief of these sufferers. A very liberal response was made to this call as you will note from the Treasurer's Report, showing that the members of our Order are ever ready to respond to the call for aid from those who need our assistance.

About the time of these cyclones Corps No. 36, at Howard, Kansas, was so unfortunate as to lose all of its property by fire. Application was made to the Department by the Corps President asking aid from the Corps through General Orders to help them replace their hall, organ, and Corps property.

But upon learning that there were Corps far more unfortunate than themselves this application was withdrawn saying "Give all to those Corps which are more unfortunate than ourselves."

The self sacrificing spirit here manifested by this Corps is worthy of highest praise; and by earnest work this Corps is gradually replacing its loss.

There has also been expended from the Department Relief Fund during the year \$35.00 to the library funds to each of the Homes at Dodge, City and Atchison.

NATIONAL CONVENTION.

For a full report of the proceedings of National Convention, attention is called to the report of the Delegate-at-Large. The Kansas Delegation present numbered fourteen, and with few exceptions attended every session of Convention. Kansas was especially honored by the National Convention by the election of our beloved sister and Past Department President Mrs. Margaret R. Wickins as National President.

The Convention was one of great interest and many knotty points were discussed and settled. Two lines from a poem,

"Boys are only men grown tall,
And hearts don't change much after all,"

were brought to my mind very vividly at this time, and I thought, National Conventions are only Department Conventions grown tall, and women don't change much after all. We left Washington after a week's pleasant sojourn and feel that never again will a National Convention be to us what this one was. We will not soon forget our beautiful Capital of the United States, down whose broad Pennsylvania Avenue marched thousands of soldiers keeping step to martial music as they did in May, 1865, when the remnant of the mighty host that had fought for their country's honor and flag, marched in Grand Review down this selfsame street.

Of all the historic places of interest in and around Washington the one fraught with the deepest meaning is that of Arlington Heights—once the home of Robert E. Lee, who here decided the most momentous question of his life, and cast his lot with the enemies rather than with the friends of his country; now, the last resting place of 16,000 of our brave Boys in Blue who sacrificed their lives as friends rather than enemies of their country.

Standing on those beautiful grounds we were surrounded on all sides by marble shafts and granite columns, and stretching

away as far as the eye could reach were the small white headstones, each marking the grave of one who has gone to join his comrades in the silent "bivouac of the dead." And I realized more deeply than ever before the awful sacrifice which made it possible for us to live in a free and united country.

Near the center of the grounds is a granite sarcophagus placed over a large vault in which are deposited the remains of 2,111 unknown soldiers gathered from the battle-field.

From this monument to the Unknown Dead has arisen the beautiful custom adopted by the Grand Army and Woman's Relief Corps of erecting a mound in all our cemeteries and dedicating it to the Unknown Dead.

REUNIONS AND CAMP-FIRES.

The State Reunion was held at Wichita Aug. 15-20. The 17th was set apart as Woman's Relief Corps Day by the local committee of the Grand Army, which also provided a large tent on the grounds to be used as Department Headquarters. This tent was supplied with chairs, table, and register and was a welcome place of rest. In the afternoon of this day Corps No. 40 of Wichita exemplified the ritual in their large and pleasant hall. More than three hundred members attended this meeting.

In the evening an enthusiastic Woman's Relief Corps camp-fire was held in the speakers' tent on the grounds to which thousands of people listened.

The Fifth District Reunion was held in Abilene at the same time of the Fifth District Soldiers' Reunion and was both pleasant and profitable. At this time Corps No. 63 of Abilene exemplified the ritual which was followed by an enthusiastic camp-fire. We believe these reunions result in much good and strengthen our Order and assist the work in which we are engaged.

It was a pleasure and privilege to accept the invitation to accompany Commander-in-Chief Weissert, Department Commander Greene, National President Mrs. Wickins, and others on the Staff of each, on the official tour of the Commander-in-Chief in Kansas. But few places could be visited owing to the limited time which could be given by the Commander-in-Chief

to his visit in our State. The royal receptions tendered the Commander-in-Chief and party at Salina, Abilene, Manhattan, Topeka, Kansas City, and Parsons showed the interest which the people of the State manifest in the grand organization to which we are Auxiliary.

DESIGN FOR WORLD'S FAIR.

The last Department Convention voted to send a Woman's Relief Corps Design from the State to be placed in the Kansas Building at the World's Fair. This matter the Convention voted should be left with the new Council. After much hard work in securing just what was wanted, a Design was found that seemed to meet our requirements. This Design was then approved by the Council, as was also the plan of raising money for the same. Circular Letter No. 3, describing the Design was sent to each Corps President, Members of Council, and Department Aides. The Design was then placed in the hands of the artists for execution. Prof. G. M. Stone will do the painting, and Prof. Henry Worrall, the wood carving. Both of these artists reside in Topeka and are well and favorably known.

This Design will be ready to be sent to the World's Fair at the proper time. In response to the foregoing Circular Letter, the Members of Council and Department Aides, as well as Corps generally, responded liberally. To them I return my grateful appreciation of their hearty co-operation and generous assistance. To Mrs. Lewis Hanback am I indebted for kind assistance in securing the designer and artists; she has been untiring in her zeal for the proper representation of our Order at the World's Fair.

CONCLUSION,

In closing this report I desire to thank the Department officers one and all for the hearty co-operation, and cordial and earnest support they have given me in the work during the year. Never could there be a more united and harmonious Council than this one, and if my successor finds the same loyalty, the same friendship, the same noble spirit, governing her Council

she will indeed be blest. Each member of the Council has cheerfully given her time and thought in furthering the interests of our Order. The fraternal ties thus cemented by this Council will not be easily broken.

Not only to the Department Officers do I wish to extend my gratitude but to the members of our Order throughout the State, and to the various Departments from whom many valuable suggestions and recommendations have been received and woven into the work and which have contributed much to the success of the work of this year.

Were I to make personal mention of the comrades of the Grand Army who have so loyally aided this Department during the year, their names would be legion. From the Department Commander to the soldier in the ranks are due my sincere thanks for the many courtesies received, and advice given, which have materially aided in promoting the work to which the Grand Army of the Republic and its Auxiliary are mutually pledged.

With the Division Commander of the Sons of Veterans, a pleasant and profitable correspondence has been carried on during the year, and we are glad to note that their Order is increasing in membership and improving in the efficiency of its work. We must not forget that upon the Sons of Veterans will eventually fall the mantle of patriotism, which prompted their fathers to offer their lives a willing sacrifice upon the altar of their country.

Let us in every way possible aid the Sons, and help advance the interest of their Order.

RECOMMENDATIONS.

1ST. That the incoming President be furnished with a list of the decisions of the Ninth Annual Convention within 15 days after its adjournment.

2ND. That the ratio of representation to Department Convention remain the same, one for every 35 members, and one for the final fraction over the half.

3RD. That the per capita tax remain 8 cents.

4TH. That this Convention memorialize National to place

the Treasurer's bond on the "free list," and that it be sent to Department Secretary by National Treasurer in time to be sent to the Corps with the Election Return blanks.

5TH. That Department Instituting and Installing Officers keep a book, wherein shall be recorded the name, number, and date of all Corps organized during her term of office; also Corps Presidents' names, and lists of Charter members. This is an important part of Department records and helpful to the new incumbent.

6TH. That the sum of \$105.50 now remaining in the Treasury from the Cyclone Fund be placed with the Relief Fund.

7TH. That only the names of voting members present at Convention appear on the roll in the printed proceedings.

8TH. That the Department Secretary send out specimen sheets of our method of book-keeping to each Corps, as many Treasurers would be glad of information on this subject, and as the work now is not uniform.

9TH. That at the next Department Convention, ribbon badges of honor be given by the Department to the members of each delegation whose reports are received at Headquarters by the sixth of the month, after close of each quarter of the year, and who have not suspended a member during the year.

10TH. That this Department place the Design for World's Fair, after the close of fair, in the rotunda of the Kansas State Capitol building.

Report of Junior Vice President.

Mrs. Alice M. Seeds, Department Secretary:

"The years have linings just as goblets do,
The old year is the lining of the new
Filled with the wine of precious memories,
The golden *was* doth line the silver *is*."

Standing today upon the threshold of this encampment occasion, with the year passing in review before me, the recesses of my mind and heart are mirrored by these lines of the poet.

The memories of the happy associations, of achievements made in our co-operative relations, together with the prospect of again assembling to hold converse upon the same, make the golden *was* that lines the now silver *is*.

Organized as we are, to perpetuate the memory of valor, self sacrifice and patriotism, unsurpassed by any soldiery that every trod this earth, we can well say that memory is the matrix in which the germ of our existence took root and sprang into life.

Inspired by the holy sentiment of the object of the Woman's Relief Corps, I eagerly sought a membership therein and have found much delight in my relation to Corps No. 149. When honored, one year ago, with an election to Junior Vice of this Department, I was sensible of the exaltation given me, and I felt in my heart a zeal and readiness to respond to every call of duty, and to perform faithfully and to the best of my ability everything the office required of me. This zeal has remained with me and the fact that the prominent feature of my report is brevity is attributable, to a large extent, to a want of demands made upon me; but as our lives are made up of little things so, you will see, is my report.

On July 29 last I entertained at my home the members of the Grand Army Post, Woman's Relief Corps, Ladies' Aid

Society and Sons of Veterans of Norton. I believe in these gatherings. They strengthen the mystic bonds which unite us in a common purpose, and inspire all to nobler endeavors and higher aspirations.

On October 26th, in response to an invitation received, I inspected Corps No. 183, at Oberlin. Again on November 12th by invitation it was my privilege to inspect Corps No. 26, at Colby. At each of these cities I was most hospitably received and entertained. The sisters of these respective Corps gave evidence of an interest in and concern for the prosperity of our beloved Order which bespeaks the security of their happy future.

November 4th, 5th and 6th it was my pleasure and privilege to entertain Mrs. Mary B. Allen of Oberlin during which time she inspected Corps No. 149 at Norton. In the evening of the same day the Corps gave Mrs. Allen a reception which was participated in by the Post, Sons of Veterans, and Ladies' Aid Society. Supper was served, after which a "feast of reason and flow of soul," partaking of the nature of a "Camp Fire," was indulged in.

On the evening of December 12th I conducted an "Old Folks Concert," from which we realized \$45.00 which has been used exclusively for Relief Corps work.

On December 31st our own Mrs. Wickins, now honoring the exalted position of National President of our Order, passed through Norton, unknown to anyone, on her way to Oberlin. I became informed of the fact immediately and ascertained also that she would return the following Monday. A promise was exacted of her that she would submit to the trying ordeal of a reception. All arrangements were perfected and as the hour approached for the arrival of the train, I sent the most desirable escort I could think of, my husband, to meet our honored National President.

Imagine our disappointment when instead of Mrs. Wickins, came a telegram announcing her inability to be with us.

The 5th, 6th and 7th Districts were given me in which to make an effort to institute new Corps. I have written letters to the number of over one hundred but from various causes have been unable to organize any new Corps in the Northwest. My

late her on the auspicious closing of this administration.

This appreciation shall find evidence in my continued zeal for our growth as an Order. I intend that patriotism for the Woman's Relief Corps shall be an energizing faculty of my soul.

In compliance with Rules and Regulations I have the honor to herewith submit to you and the members of the Ninth Annual Convention, the following report of the condition and membership of the Order in this Department for the year just closing.

I shall confine myself exclusively to the figures and facts of my office, which are as follows:

When you assumed command there were 230 Corps reported in good standing, with six suspended Corps, three of which were reinstated and three, numbers 30, 81 and 134, remain suspended, not having reported for over two years, making a Roster of 236 Corps.

One thousand nine hundred and sixty-three members reported suspended in our reports to National is due to a great extent to the neglect of duty of those officers, who promised to do their duty by their respective Corps. Incorrect reports necessarily increase greatly the correspondence—a correspondence costing both time and money, and in order to avoid this it is the duty of the Corps Presidents to carefully examine and compare the reports before signing them and let nothing, except it be of the most serious nature, prevent reports from being mailed immediately after the last meeting of the quarter, thereby relieving much anxiety and correspondence to both Corps and Department officers, at least to the Department Secretary. I wish to express my sincere thanks to those who were prompt and careful with this part of their work and can assure them their promptness was fully appreciated.

In addition to keeping a record of all charter members of the newly organized Corps, I have recorded the charter mem-

bers of a number of the old Corps, and would recommend that this be continued, but that a suitable book be procured for that purpose, as valuable space in the Charter Roster is being taken that should be used for other purposes.

I would also recommend that the Department Secretary in sending quarterly blanks to Corps shall indicate in red ink on line 15, "number remaining suspended last report," which shall not be changed; the same to be a copy of column 16 on consolidated report of previous quarter.

And now, Mrs. President, in surrendering the appointment with which you have honored me, I desire to thank you for courtesies received at your hands. I have endeavored at all times to perform all duties assigned me to the best of my ability and for the promotion and welfare of this Department. Our official relations, Mrs. President, which have ever been pleasant will soon be severed. I am deeply indebted to you for counsel and co-operation, which has always been an inspiration to me.

I wish also to thank the members generally for the helpful, cheering words that have come to me during the year from the various Corps.

I have looked forward to this time with pleasure and anticipation of making personal acquaintances with those with whom I had correspondence, and trust that the friendships formed may be as lasting as our beloved motto, "Fraternity, Charity and Loyalty."

Mrs. Mary A. Sturges, an army nurse, died at Kansas City, Kansas, December 29, 1892, at the advanced age of 84 years. She was born in Montreal, Canada, her parents moving to New York City in her infancy. There she grew to womanhood, later in life removing to Peoria, Ill. During the Rebellion she served her country in the Army of the Tennessee. Commissioned by Mary A. Livermore, Nov. 11th, 1861, she entered the Adams Block Hospital at Memphis, Tenn., where with loving heart and willing hands she administered to the wants of the sick, wounded, or dying soldier until the war closed. She was buried under the auspices of Burnside Corps No. 1, W. R. C., of which she had long been an honored member.

This report shows the death of five past presidents and one conductor.

One sister, the secretary of Corps No. 201, Towanda, was killed in the cyclone last April. I received no official notice of

it but include it in this report, with the statement that the chaplain was also injured in the same storm. Owing to the destruction of public buildings their Memorial Services were held in a newly constructed blacksmith shop.

Corps No. 75, at Severance, presented the Sons of Veterans with a beautiful flag on Memorial Day, costing \$26.40. This Corps owns a lot in the cemetery which they have beautified by setting out in shrubbery and evergreens.

Corps No. 175, at Atwood, presented Atwood Post with a handsome flag on Memorial Day. The gift was highly appreciated and will be kept with care.

The Corps at Abilene, No. 63, furnished a fine report of Memorial services. Rev. Dr. Blayney preached a fine sermon on the Sabbath to a full house. A fine programme was prepared. A large procession marched to the cemetery, where 35 soldiers' graves were decorated. Thirteen graves of soldiers' wives and seven graves of members, were also covered with beautiful flowers during the sad but impressive services.

Corps No. 84, at Cherryvale, had Gov. Humphrey for orator of the day at the Memorial Services.

Corps No. 149, at Norton, had the inspiring presence of Mother Bickerdyke who talked to her children as only Mother Bickerdyke can, both afternoon and evening on Memorial Day.

Col. J. H. Gillpatrick, of Leavenworth, was the orator of the day at Troy, No. 190. Corps No. 70, at Emporia, reported a large Memorial service at Whitley Opera House, in connection with Preston B. Plumb Post, No. 55, in memory of Comrade Col. Preston B. Plumb. Commander Green, of the Department of Kansas, and Judge B. F. Simpson, of Topeka, pronounced honorable eulogies upon the life of our honored comrade.

Mrs. Mary Clapp, Corps Chaplain Corps No. 176, at Yates Centre, included in her report a disapproval of public dinners on Memorial Day. The reason seems timely and it may be well for this Convention to take action so that the day shall not be perverted, and lowered to a day of levity, or be made a simple picnic gathering of money-making schemes. The only object is the Memorial Service and the teaching the spirit of patriotism and love of country, and a reverence for our brave soldiers

who gave all to save our country in the day of peril. We owe it to them and their heroic deeds to perpetuate their memories all along down the coming years.

Nearly all the Corps Chaplains made special mention of decorating a grave representing the "Unknown Dead." In many places it was a prominent feature of the Memorial services. Both mounds and temporary monuments were used and completely covered with flowers. This part of our Memorial services should not be forgotten but encouraged. The constant rains prevented in some places any services at the cemeteries, at others only the committees could go out and decorate the graves.

I would call attention to the Memorial blanks. There seem to be two kinds in use, and while this is the case our reports will necessarily be imperfect. All the blanks should contain these two items among the others, namely, How many soldiers' graves decorated? How many members' graves decorated? All our blanks should be uniform and the reports made promptly.

By this report it will be seen nearly 100 Corps made no report whatever of their Memorial services. As long as this is true our Department will not make a creditable showing in the larger or National reports.

The reports showed a good interest throughout the Department among the people in attending the Memorial services. At many points business houses were closed during the services, showing they honored the day and the memory of our fallen heroes.

The roll of our departed sisters here presented reminds us that the wheels of time will soon bring us to the border-land "Where Lucy is," as our beloved General Hayes said a few moments before he passed the stream of time to join the wife of his young manhood beyond the storms of earth. In his death our Order, as well as the nation, sustains a great loss and suffering humanity a sympathizing friend. General Hayes' voice will no longer be heard in the defence of all loyal and charitable work, but his good deeds will follow him. And what we do for our loyal "boys in blue" we must do soon. For our

hands too will soon be folded in death, and life's work ended. Our noble Order enjoys the high distinction of standing by the side of our nation's heroes, as they did in 1861-5, by prayers and the work of the Christian Commission. By being at the front they won our highest esteem, fighting for our homes and our flag and we assure them they shall not be forgotten.

Our work is to make them comfortable and happy as they march on in the last campaign of life, and when they fall from the ranks to wrap the old stars and stripes around them, and with loving, loyal hands, lay them to rest until the reveille from beyond the river awakens them, not to battle, but to peace and victory. And may not He who takes notice of our good deeds and charity, say "well done."

In closing my report I desire to express my thanks to the Department officers and members for their help and uniform kindness to me during the year.

Report of Counselor.

ALICE M. SEEDS,

Department Secretary and Members of Ninth Annual Convention:

I have the honor to submit the following report as Counselor for the year just ended.

In accepting the office, Mrs. President, I felt that it might sometimes be my privilege to advise in the work which I had directed during a previous year, but your executive ability and general knowledge of the work of the Order has made my labors in that direction very light indeed.

In several cases of perplexity you turned to me as a friend for advice, and I can truly say that it has been given willingly and promptly, with an earnest desire to assist you in every way possible.

Numerous letters from officers and members came to me asking that I might give them light upon matters pertaining to their work in Corps. Permit me to again repeat the old story, "The duty of Counselor is to confer with the Department President *only* and *not* with officers and members of Corps." Much of the misunderstanding which arises among Corps members is caused by neglect to become familiar with the laws of our Order. I therefore most earnestly recommend a careful study of the Rules and Regulations and the Red Book, which is such a help to us all. Many difficulties could thus be amicably settled, without referring to higher authority. I wish to thank you, Mrs. President, for the many courtesies extended to me; also to the entire membership for the kindly expressions of good will which always greet me wherever I go.

The following are the decisions given during the year:

Question. Can money to be sent to the Orphans' Home in Atchison be taken from the Department or the Corps Relief fund?

Answer. Yes, by vote of Corps or by vote of Council, as the money thus appropriated is for the benefit of soldiers' orphans. This question is fully answered in the Red Book.

Q. Can money be taken from the general fund to assist a person who is in no way connected with a soldier, sailor or marine?

A. No. We are organized to assist only the Union Veteran and his dependent ones.

Q. Would it be right to grant a special dispensation for a period of thirty days to reinstate members for fifty cents each?

A. No. Members can be reinstated only through the proper channel. See R. and R., Chap. 5, Art. 4, Sec. 2.

Q. Has a Corps the right to adopt an opening ode other than the one approved by the Woman's Relief Corps?

A. No.

Q. Can a Corps in arrears for dues for two years, and then becoming reinstated, be entitled to a delegate and alternate?

A. Yes. The fact of its paying all arrears, places it where it once was, in good standing.

Report of Delegate-at-Large.

In accordance with established custom I herewith submit my report as Delegate-at-Large to the Tenth National Convention.

As a complete report of the proceedings of this Convention will soon be in the hands of the Corps of this Department and the recommendations and decisions of the Convention have already been promulgated in General Orders, I shall be brief.

I accompanied the Department President and staff on the trip to Washington; nothing happened to mar the pleasure of the journey, except the delayed trains which are usual on such occasions. From this cause we did not reach Washington until the morning of the 20th, the day of the greatest parade ever participated in by the members of the Grand Army of the Republic as an organization.

Wednesday at 10:30 the Convention assembled at the Sixteenth Street Baptist church and was called to order by the National President and opened in form. The National Chaplain being absent, the Chaplain of John A. Logan Corps, of the Department of the Potomac, officiated.

All the Past National Presidents who were present were then presented to the Convention and made their best bows.

The Chairman of the Citizens' Committee was then announced as desiring admission and by vote of the Convention was admitted. He made us a nice speech and tendered to the Convention the greetings and hospitality of the city.

The President's address was a clear business statement of the condition of the Order and contained many good suggestions, showing an increase of 13,218 in the membership during the year, making a total membership of 130,789, and \$61,463.63

in cash had been expended in relief, and \$34,138.34 was turned over to the Posts, leaving a balance of \$77,517.17 in the Relief fund of the Corps, and \$122,535.81 in the General fund.

At the conclusion of the reading of the President's report, Mrs. John A. Logan was announced and escorted to the President's side and introduced to the Convention. Mrs. Logan, as President of the Ladies' Citizens Committee, extended to the Convention the courtesies of that Committee and invited the Convention to meet in the New York Avenue Church to hold their Convention, which invitation was accepted.

This worked a great hardship on the ladies of the Department of the Potomac, who had made splendid arrangements for serving lunch at this church, and had the church most elegantly decorated.

The Convention continued in almost continuous session day and evening, Friday afternoon the election of officers being reached. Our own Past Department President and National Senior Vice President, Mrs. Wickins, was elected National President.

Saturday evening the installation took place, after which Mrs. Sweet, the delegate from California, presented the National President with a very handsome gavel made from California wood, and the retiring President, Secretary and Treasurer were each presented with a scenic painting on California wood.

During the Convention we were visited by Commander-in-Chief Weissert and members of his staff, also by Commander Greene and members of his staff, as well as many other distinguished comrades.

In closing this report I desire to say that we were most hospitably entertained by the good people of Washington and the untiring efforts of the members of the Potomac Corps to provide for our comfort will ever be remembered by all the members of the Tenth Annual Convention.

Mrs. Flora P. Hogbin, National Secretary, having just arrived, was introduced to the Convention.

The roll call was completed and all visitors seated in the rear of Delegates.

Minutes of morning session read and approved as corrected.

Mrs. Fannie Potts, Instituting and Installing officer, being absent, her report was read by the Secretary and referred to a Committee. (See list of Committees.)

Mrs. Ellen M. Kimball, Chief of Aides, read her report which was then referred to a Committee. (See list of Committees.)

The report of Mrs. Harriet S. Coulter, Delegate-at-Large, was called for, but owing to illness in the family Mrs. Coulter was absent.

Mrs. McCarthy asked and obtained permission to present a resolution to the Convention.

Resolution was as follows:

WHEREAS, We highly appreciate the great honor that has been conferred upon this Department by the election of Margaret R. Wickins as National President, and

WHEREAS, Knowing her as we do to be entirely worthy and deserving of this and any additional honors that may be bestowed upon her,

Resolved, That the Corps of this Department be asked to contribute toward the furnishing of a room in the National W. R. C. Home at Madison, Ohio, to be known as the Kansas M. R. Wickins Room, and further

Resolved, That a Committee of three be appointed by the Department President to correspond with the Secretary of the Home, and that said Committee secure and forward contributions and report the same at the next Department Convention.

Mrs. Kimball moved, Mrs. Martin, Senior Vice President, seconded, that the resolution be adopted.

It was asked if it were not feasible to have such a room in the home at Dodge City.

Mrs. Harris spoke in favor of the resolution.

Mrs. Belle Reid said she understood that the rooms were furnished already with carpets.

Mrs. Besack spoke in favor of the resolution.

Mrs. Evatt: "Why not favor our own State?"

Mrs. Speer spoke in favor of resolution.

Mrs. Lund asked that National President give more information.

Mrs. Wickins explained that Mrs. Wittenmeyer was mother of the thought that not only old soldiers but army nurses should be cared for. The National Home at Madison, Ohio, is for this purpose, and for the widows of soldiers who have no one to care for them.

Departments are furnishing rooms as monuments to their work, and endeavor to give the inmates such care as your own mother would like.

Mrs. Moore stated that she had wanted to help found a Home in our own State for this purpose and had taken steps in the matter, but found the matter not practicable at this time.

Mrs. McCarthy suggested that the decorations for the room be in our State color so that the occupants would feel more at home.

Motion carried.

Mrs. Wickins said: "I am thankful for this expression of your appreciation of the little I can do. It is but another tie that binds heart to heart."

It was moved and seconded to hold a night session.

Motion lost.

Meeting adjourned to meet at 9 a. m. Wednesday morning.

SECOND DAY.

PITTSBURG, KAS., February 22, '93.

MORNING SESSION.

Convention called to order at 9 a. m. All united in singing opening ode and repeating the Lord's Prayer. The Conductors reported all present members of the Order. The minutes of previous session were read and approved.

The Senior Vice President, Mrs. Ida C. Martin, then stepped to the side of the Department President and presented her with a gold diamond-studded badge in the following words:

Mrs. President:—It becomes my pleasant duty on this occasion to convey to you an expression of the esteem and admiration that exists for you in this Department.

Occupying the responsible position that has been yours, we feel and know that you have ever endeavored to perform every duty faithfully and conscientiously. We love the W. R. C. and are proud of its prosperous condition. We love the women of America; they have made a record that appeals to the recognition of men. England has a queen—in America every woman is a queen. In trying hours of the Republic when men took their lives in their hands and threw themselves into the breach, you performed your work at home. Without your support and encouragement they would not have been able to endure the conflict and we look with pride on the services you rendered in that hour.

Dr. Laurence: If any one venerates a mother more than I do I have not met him. I hope to be able to work for years for the S. of V. and the W. R. C.—to work for principle and perpetuate liberty.

W. Y. Morgan: Women of the W. R. C., the Sons think it the highest honor to be placed on the Committee to visit you—even volunteers come, come as to home. Colonel Agnew states that he had but to go to President Moore and an answer always came and came effectively.

Mr. Johnson: Love depends not on age; we are all strictly young men, single men, open for proposal.

Mr. Harrington: My best recommendation is to be introduced as from Mrs. Chase's town and I am not surprised to be thus introduced by anyone who knew Mrs. Chase.

While this Committee was present a second delegation arrived bearing the sad intelligence that the Past Commander-in-Chief, Leland J. Webb, died this morning at Topeka.

Mr. Hoffman was introduced and said: My visit is not consistent with the others. I hold in my hand a telegram. L. J. Webb died at 5 a. m. We have sustained a loss of the father of our Order. Memorial services will be held tonight.

I have not the pleasure of being a committee, not a husband or a wife but love the W. R. C.

An invitation was extended the W. R. C. to attend Memorial services to be held in the M. E. church this evening. Mrs. Harris moved that the invitation be accepted. Motion carried.

Mrs. Wickins moved, seconded by Mrs. McCarthy, that as a token of our sympathy and admiration of the work he has done and the honor of his position, the Convention send a telegram of condolence to his family. Carried.

At this point Quartermaster General Loganstein was announced and escorted to the platform by Mrs. Wickins, and was introduced to the Convention.

Gen. Loganstein said: I am not egotistical enough to take to myself your expression of approbation but take it for the Order of Sons of Veterans of Kansas and of the United States who are all bowed down with grief at the loss of one who cannot be replaced, who was firm, true and steadfast. No words of mine can do justice to the work of the Orders or to the truly grateful hospitable welcome given me.

The President said: We are glad to welcome you and sympathize with the Sons of Veterans. The W. R. C. has lost a friend whom they were always glad to meet.

The Sons were escorted from hall by Conductors.

Upon suggestion of Miss Allie Myers, it was moved and seconded that a floral tribute be procured to be placed on altar at Memorial services and afterward be sent to the family at Topeka.

This matter was referred to the Committee on Telegrams and Courtesies.

Mrs. Mattie Leland, Chairman of Committee on Inspector's report, made the following report:

AFTERNOON SESSION, FEBRUARY 22.

Convention called to order by Department President at 1:30 p. m.

Conductors reported all present in possession of the proper password of the Woman's Relief Corps.

Minutes of first and second council meetings read and adopted. Convention adjourned to witness parade.

Convention again called to order at 3 p. m. and the Department President said it gave her great pleasure to introduce to the Convention Comrade G. M. Parks, of Washington, our standard-bearer of today, who also carried the W. R. C. banner in the parade at Washington.

Comrade Parks: This is a great and agreeable surprise that I shall remember with more pleasure than many others. As it is near my 50th birthday I shall call it my birthday celebration, and thank you for the opportunity, honor and privilege.

On motion of Mrs. Lapham a vote of thanks was tendered Comrade Parks by the Convention.

Rev. Hogbin, of Sabetha, was introduced as the husband of National Secretary. He said:

I am glad to be introduced as the husband of Mrs. Hogbin. As I listened to the greetings of comrades my first impressions were, the boys all seem old—the sisters younger than the

brothers. I hope those who linger will transmit the memories of those who have fallen to those who shall follow.

A Committee of the Sons of Veterans was announced and admitted. Col. Clay D. Herod of the Committee, said:

I am proud to be with you again, especially because I find my wife here. We do not need a trained soldiery to fight out treason. We did not have them in the Revolution, Mexican or Civil wars.

Sanders—Pittsburg: We had a stranger to dinner, a young lady whose mother is here and when asked if the committee from the Sons of Veterans had been here replied that those Committees were always a bore.

Hoffman—Emporia: Considered the Encampment incomplete without the ladies present.

The Department President announced that at the request of Mrs. Julia McCarthy she had relieved Mrs. McCarthy from the Chairmanship of the Committee on furnishing the Kansas M. R. Wickins room, and Mrs. Ida C. Martin, of the Committee, was appointed Chairman.

A Committee from the Ladies Aid Society was announced and admitted. Mrs. Horne of the Committee, said:

When your Committee arrived to visit us we were all in tears at the sudden news of the death of Past Commander-in-Chief, L. J. Webb; but we are glad to come and renew our fealty to you, and work with you in the same great cause.

The minutes of third Council meeting read and adopted.

Mrs. Lapham introduced the following resolution:

WHEREAS, the Department President has had all the work and correspondence of securing the design for the World's Fair exhibit, be it

Resolved, That she be Chairman of a Committee of three, the other two being the incoming President and Chairman of Executive Board, to see the work is completed and exhibit placed in position at Fair and cared for after close of Fair.

Moved by Mrs. Leppleman, seconded by Mrs. Hogbin, that it be adopted. Carried.

Complete roll call showed 243 voting members present.

Moved by Mrs. Ward, seconded by Mrs. Bonney, that no Committees except authorized Committees from the other

Orders be admitted during this afternoon's session. Carried.

Department President announced that election of officers was next in order and appointed as tellers, Mrs. Harris, Mrs. Martin, Mrs. Lapham and Mrs. McGhie.

Moved and seconded that in order to save time the Tellers retire to ante-room, with the parties who nominated candidates to count the votes. Discussion followed. Motion lost.

The Department President announced that nominations for President were now in order.

Mrs. McCarthy nominated Mrs. Lucy R. Jones, of Norton, the present Junior Vice President, seconded by Mrs. Bridegroom, Mrs. Patch, and others.

Mrs. Ward nominated Mrs. Belle Reid, of Grenola, seconded by Mrs. Watson, Mrs. Clark and Mrs. Noley.

Mrs. Besack, of Washington, nominated Mrs. Ida Wilson Moore, of Abilene, the present President, amid applause. Mrs. Moore declined the nomination with thanks and stated that her successor would have no more cordial support than from the Past Department President.

Mrs. Aten nominated Mrs. Julia A. Chase, of Hiawatha, seconded by Mrs. Gerow and the Corps of the First District.

Mrs. Butts nominated Miss Allie Myers, of Olathe, seconded by Mrs. Pond and others.

There being no further nominations, nominations were declared closed, and a ballot taken.

The first ballot resulted as follows: Whole number of votes cast, 240; necessary to a choice, 121. Mrs. Jones, 74; Mrs. Reid, 30; Mrs. Chase, 65; Miss Myers, 71. No choice.

Mrs. Reid withdrew her name as a candidate.

The second ballot was taken and resulted as follows: Whole number of votes cast, 240; necessary to a choice, 121. Mrs. Jones received 92; Mrs. Chase, 60; Miss Myers, 88. No choice.

Mrs. Chase having received the lowest number of votes on the second ballot, according to Rules and Regulations, her name was dropped.

The third ballot was taken and resulted as follows: Whole

number of votes cast, 236; necessary to a choice, 119. Mrs. Jones received 134; Miss Myers, 102.

Mrs. Jones having received the majority of all votes cast was declared duly elected.

Mrs. Jones was introduced to the Convention and responded by an appropriate speech.

Nominations for Senior Vice President were declared in order.

Mrs. Bradford placed in nomination Mrs. Edith M. Wood, seconded by Mrs. Marsh and others.

Mrs. Peters nominated Miss Allie Myers, seconded by Mrs. Lapham.

Miss Myers stated that we owe a compliment to Pittsburg for the royal entertainment given us, and according to an established precedent to compliment the place of our meeting, therefore she would not be a candidate against Mrs. Wood and so withdrew her name.

There thus being but one nominee, Mrs. Gerow moved, and it was seconded, that the Rules be suspended and Mrs. Wood be elected by acclamation. On motion Secretary was instructed to cast the ballot of the Convention for Mrs. Wood for Senior Vice President for the ensuing year, which was accordingly done, and Mrs. Wood duly declared elected.

Mrs. Wood was then presented to the Convention and in a few words thanked them for the honor bestowed upon her and her Corps in thus electing her Senior Vice President.

Nominations for Junior Vice President were then declared in order.

Mrs. Taylor nominated Mrs. Julia A. Campbell, of Hutchinson, seconded by Mrs. Gerow and others.

Mrs. M. J. Hart nominated Mrs. Willifred, seconded by Mrs. Jacobs.

Mrs. Lapham nominated Miss Allie Myers, seconded by Mrs. Miller.

Nominations closed and ballot taken with the following result: Whole number of votes cast 237; necessary to a choice, 119. Mrs. Campbell received 85; Mrs. Willifred, 11; Miss Myers, 123; Mrs. Heacock, 18.

Miss Allie Myers having received a majority of all votes cast was duly declared elected Junior Vice President.

Miss Myers was presented to the Convention and made a neat little speech.

Nominations for Treasurer being in order, Mrs. Rogers nominated Mrs. Hinkle, of Emporia, seconded by Mrs. McCandless.

Mrs. Logan nominated Mrs. Belle Reid, of Grenola, seconded by Mrs. Ward.

Mrs. Chapman nominated Mrs. Evalyn Bradford, of Concordia, seconded by Mrs. Sargent and others.

Mrs. Besack, of Washington, nominated Mrs. Lund, the present Treasurer.

Mrs. Lund thanked the Convention for past honors and stated that circumstances and her health would not permit her to continue in the position and declined the nomination.

Mrs. Wickins desired that the Convention express its appreciation of Mrs. Lund's services as Department Treasurer by a rising vote. Carried unanimously.

Mrs. Lamb nominated Mrs. E. Newman, of Burlingame, seconded by Mrs. Adams.

A Committee of Comrades from the Grand Army was announced. Business was suspended and the Committee, consisting of Comrades Milner, Harris and Ford, were admitted and escorted to the platform.

Comrade Milner said: I was delighted when I heard the Department Commander read my name on this Committee. I wished to come when you were not so tired with business. Your W. R. C. reports are simply models and I wish the women's societies of the churches were carried on similar to yours. You have a most glorious work; giving the Posts money; carefully looking out for people who are suffering; training the boys and girls to be patriotic, and now going to have a chance to say something in politics—the new element is woman. Glad to know Kansas woman is at the head and how thoroughly your work is done. We bring you the greetings of the Grand Army.

Comrade Harris: I have not the eloquent tongue of Ber-

nard Kelley or Milner but no honor is more appreciated than visiting the W. R. C.

The Department President said: Nothing affords us greater pleasure than to receive the greetings of the Grand Army. Nothing is more appreciated or more anxiously looked forward to. We can only pledge anew our unswerving allegiance to the Grand Army of the Republic.

The Committee retired and the regular business of the Convention resumed.

A ballot was taken on the nominations for Treasurer, with the following result: Whole number of votes cast, 235; necessary to a choice, 118. Mrs. Bradford received 140; Mrs. Hinkle, 17; Mrs. Reid, 38; Mrs. Newman, 30. .

Mrs. Bradford, having received a majority of all the votes cast, was duly declared elected Department Treasurer.

Mrs. Bradford was presented to the Convention and made a few appropriate remarks.

Convention adjourned to meet at 9 o'clock, Thursday morning.

THIRD DAY.

PITTSBURG, Kansas, February 23, 1893.

MORNING SESSION.

Convention called to order at 9 a. m.

All united in singing the opening ode and repeating the Lord's Prayer.

Conductors reported all present in possession of the proper password of the Woman's Relief Corps.

Minutes of last session read and approved.

Minutes of fourth Council meeting read and adopted.

Roll of Convention called.

Mrs. Belle C. Harris moved that the retiring officers finish the work of Convention, if not finished prior to Installation of officers. Motion seconded and carried.

The Tellers were called to platform and nominations for Chaplain declared in order by Department President.

Mrs. Dickson nominated Mrs. E. E. Ranney, of Burlington, seconded by Mrs. Miller, Mrs. Markley and others.

Mrs. Ennis nominated Mrs. Bordwell, seconded by Mrs. Harris and Mrs. Killmer.

Mrs. Hart nominated Mrs. Willifred, seconded by Mrs. Jacobs.

Mrs. Shaw nominated Mrs. Markley, seconded by Mrs. Swan.

Nominations were closed and a ballot taken. A Committee of Comrades was announced. Mrs. Alrich moved, seconded by Mrs. Besack, that from this time the Tellers retire to the ante-room, accompanied by those who nominated the candidates, to count the ballots. Motion carried.

Business was suspended and the newly elected Department Commander, Bernard Kelly, and the newly elected Senior Vice

Commander, T. B. Gerow, were admitted and introduced to the Convention by the Department President.

Capt. Kelley said: I need not assure you of my attachment to, or reverence for the W. R. C.; 28 years ago as I stood on crutches in defence of the G. A. R. at Piqua, Ohio, one of the elegant ladies came and put a wreath around my neck. Ladies in war as well as peace have a place in our inner hearts. You know we have three hearts, outer, inner and holy of holies. The W. R. C. has our innermost heart. Whatever I can do to aid them I will do without reserve. If the Department Secretary will write me a letter and let me know where the two places are that have no Posts but have Corps, I and all my staff will go there and have the Posts resurrected. Am glad there are only two such spots on earth.

Comrade Gerow: I admire Kelley's enthusiasm but he lacks discretion. I have made it a rule not to visit the W. R. C. while in session because whatever women do they do with their might. My faith in them never has been shaken.

The Department President said: We appreciate this visit from the newly elected Department Commander and Senior Vice Commander more than we can tell. The Woman's Relief Corps has but one object and that is to assist the Grand Army in every way possible. We thank you for this visit and hope you will visit us again.

The Comrades were then escorted from the hall and business resumed.

The Tellers reported the following ballot for Chaplain: Whole number of votes cast 197; necessary to a choice, 99. Mrs. Ranney received 91; Mrs. Bordwell, 27; Mrs. Willifred, 43; Mrs. Markley, 36. No choice.

Mrs. Markley's name was withdrawn.

The second ballot was taken and Tellers retired to ante-room.

Mrs. Lila Brown, Chairman of Committee on report of Delegate-at-Large, read the following:

Mrs. President and Members Ninth Annual Convention:—
We, the Committee on the report of Delegate-at-Large to National Convention would most respectfully submit the following

report: Having carefully examined the report find it complete in every detail. It should be very gratifying to all workers in W. R. C. that the membership of our beloved Order has reached 130,789. That the amount expended for relief has reached more than \$60,000—leaving a balance of \$77,517.17 in this fund, and \$122,535 in General fund, which is a good financial showing. Always appreciating courtesies shown our Order in any way, we would not forget the presentation of Memorials from California Delegates. Therefore we recommend the adoption of this report.

Mrs. Patch nominated Mrs. Ward, of Sedan, seconded by Mrs. Evatt and others.

Mrs. Moore nominated Mrs. Curry, of McPherson, seconded by Mrs. Bonny.

Mrs. Robinson nominated Mrs. Chapman, seconded by Mrs. Sanders.

Mrs. Gerow nominated Mrs. Jennie E. Besack, of Washington, seconded by Mrs. Kimball.

The question of contributing towards the National W. R. C. exhibit was discussed. Mrs. Wickins took the chair and Mrs. Moore moved that we donate \$25 from our General fund for this purpose, seconded by Mrs. Besack. Carried.

The Treasurer reported \$163.65 on hand in World's Fair fund for our State exhibit.

Mrs. McCarthy moved that the \$3.90 left in Testimonial fund for Department President be donated to the Committee for furnishing the Kansas M. R. Wickins room. Seconded, and motion carried.

Mrs. Ward, of Sedan, introduced the following resolution:

WHEREAS, It has been a custom with a few Corps to serve dinner on Memorial Day either for profit or to the veterans, and
WHEREAS, It is the sense of this Convention that such

practice detracts from the solemnity of the rites due to this day, sacred to the memory of our fallen heroes, therefore be it

Resolved, That participation in any scheme for either money or merry-making upon the 30th day of May should be prohibited.

Mrs. Alrich moved to amend the resolution by substituting the words "should be disapproved" for the words "should be prohibited." Seconded and carried.

Mrs. Killmer moved, seconded by Mrs. Chase, that the resolution as amended be adopted. Motion carried.

Mrs. Flora P. Hogbin made the following report of the Committee on Resolutions:

Resolution No. 1.

Inasmuch as a great many members of our Department will be unable to visit the World's Fair,

Resolved, That the World's Fair design be taken to the next Department Convention before being placed in the rotunda of the Capitol at Topeka.

Recommended by Committee.

Resolution No. 2.

WHEREAS, in almost every Southern city a monument has been erected in memory of the Confederate dead, and

WHEREAS, Scarcely a single memorial to the defenders of the flag can be found on the sunny plains of our blood baptized State, therefore, be it

Resolved, That a Special Committee of three be appointed to solicit funds for the erection of a monument commensurate with the wealth and patriotism of our commonwealth, and further, that one-eighth of the per capita tax be donated to said fund; such monument to be built on the Capitol grounds at Topeka, alike a lasting testimonial to the valor of the Kansas soldiers and of the grateful appreciation of those who have profited by their self sacrifice.

In view of the fact that a special demand is made this year upon our Treasury for the World's Fair, and as at the time of the decision of this Convention in regard to the amount of per capita tax levied upon the members this additional expenditure was not taken into consideration, your committee is not in favor of the resolution at the present time.

Resolution No. 3.

Resolved, That each Corps be furnished two copies of the Proceedings of the Ninth Department Convention; also that one copy be sent every voting member present free of charge.

Recommended by Committee.

Resolution No. 4.

Resolved, That we petition National Woman's Relief Corps to again place on the free list Relief Reports to Commanders.

Recommended by Committee.

Resolution No. 5.

Resolved, That the Grand Army of the Republic and Sons of Veterans have our heartfelt sympathy in the loss they have been called upon to sustain in their respective organizations by the death of their Comrade and Brother, General Leland J. Webb.

Recommended by Committee.

Resolution No. 6.

Resolved, That we extend our thanks to the Railways of Kansas for reduced rates to our delegates.

Recommended by Committee.

Resolution No. 7.

Resolved, That thanks be tendered the Abilene Reflector for the prepared tablets for balloting.

Recommended by Committee.

Resolution No. 8.

Last but not least

Resolved, That our most hearty thanks and appreciation be extended General Russel Corps No. 98 and its capable Executive Committee for the admirable arrangements made for our pleasure and convenience, the beautiful decorations under which we have sat and held such harmonious and delightful sessions; to the Pastor of this church and his people; to the pianist who has been faithfully present from first to last; to the comrade janitor for his services; to the press of this city for their pleasant notices; to the citizens of Pittsburg, whose hearts and homes have welcomed us, whose beautiful badges have decorated us,

whose magnificent and seasonable hospitality has so generously on every hand greeted us.

Convention adjourned to meet at close of Installation services.

Convention called to order at 3 p. m.

Conductors reported all present in possession of the proper password of the Woman's Relief Corps.

Moved by Mrs. Harris, seconded by Mrs. Gerow, that the resolution be adopted. Carried.

Resolution No. 7.

Moved by Mrs. Besack, seconded by Mrs. Ainsworth, that the resolution be adopted. Carried.

Resolution No. 8.

Moved by Mrs. Kimball, seconded by Mrs. Gerow, that the resolution be adopted. Carried.

Mrs. Harris moved, seconded by Mrs. Wickins, that the retiring President and Secretary prepare the minutes of Convention for publication. Carried.

Mrs. Kimball moved, seconded by Mrs. Miller, that the minutes of Convention be sent direct from Abilene to the Corps and members of Convention present at this Ninth Annual Convention. Carried.

Query box opened and questions answered by Department Counselor, Mrs. Belle C. Harris, as follows:

Question.—In addressing the President, should we say Madame or Mrs?

Answer.—Mrs.

Q.—Is it legal to re-elect two members of the Executive Board?

A.—All members of the Woman's Relief Corps, in good standing, are eligible to any office.

Q.—Can a member who has been suspended, be re-instated in another State without payment of dues?

A.—No.

Q.—When the retiring President fails to send in election returns, what shall be done?

A.—The acting President should see that proper returns have been reported.

Q.—Must a Corps draft and adopt by-laws?

A.—Not necessarily.

Q.—Is a notice in a daily paper of a regular meeting legal?

A.—It is not.

Q.—Is there any Rules and Regulations later than 1891?

A.—Yes.

Q.—A member six months in arrears for dues says she will not pay them as long as *that* Treasurer is in office?

A.—If she does not comply with the law, she must be dropped at the expiration of one year.

Q.—When a charter member is suspended is she entitled to receive pay for her badge?

A.—Yes, if she is not re-instated.

Q.—Do we have a right to take funds from the Relief fund to aid members not in any way connected with old soldiers?

A.—No.

Q.—Can Treasurer receive dues when Corps is not in session?

A.—Yes.

Q.—When only one member of the Finance Committee is present at a Corps meeting, can she act upon and approve the bills?

A.—The Finance Committee does not make a report at each meeting, only quarterly. The Chairmen of Relief and Ex-

ective Committees shall audit all bills before presentation to Corps for action.

Q.—In the report of Inspector she says Corps have different initiation fees. Can they do this?

A.—Rules and Regulations says: “The initiation shall be not less than one dollar and price of badge added thereto.” Corps may charge as much more as they desire.

Q.—In making quarterly reports to Posts are we allowed to report relief work done other than money?

A.—Yes.

Q.—Can a Corps President act as Inspector?

A.—Yes.

Q.—Is it required of Corps to sing the opening ode?

A.—Yes, if they can do so.

Q.—Should a Past President be elected as a delegate to Convention?

A.—It is not advisable, as the Corps loses one vote by so doing.

Q.—Should every member vote?

A.—My opinion is, she should.

Q.—When members allow themselves to be dropped, should they retain their badge?

A.—No.

Q.—Must the Charter be in the room at all meetings?

A.—Yes. It is not legal to transact business without it.

Q.—In doing relief work are we confined to our Post only?

A.—No. We are to assist the Union Veteran and his dependent ones.

Q.—Can a President legally initiate a person unless the Initiation fee and price of badge is paid?

A.—No.

Q.—Is every member entitled to a Red Book if she purchases it?

A.—Yes.

Q.—A member three years in arrears for dues desires to return. Can she pay all dues and be reinstated without making out a new application blank?

A.—She cannot.

Q.—Is there a law to this effect, that the necessities of life be provided our disabled ones, when their pensions are inadequate?

A.—There is no such law.

Q.—Should not a member, granted a transfer card, return her badge which if not presented within one year, acts as an honorable discharge?

A.—Yes.

Q.—A member true and loyal and has paid all her dues, but will not wear or buy a badge, can she receive a transfer card?

A.—Members must comply with the law.

Q.—Should the badge of our Order be placed upon our deceased members?

A.—We have no law prohibiting it.

Q.—Should not the Corps Secretary's books show the amount of money on hand, same as Treasurer's books?

A.—Yes.

Q.—Can a President properly perform the initiation ceremony without pinning on the badge?

A.—No.

Q.—Is it understood that a member of our Order who is a loyal woman is only eligible to assistance when needy, from the General fund?

A.—It should be so understood.

Q.—When the Corps is in line of march, for instance, on Memorial Day, where is the Chaplain's place?

A.—With the Treasurer in the rear of Junior Vice and Secretary.

Q.—In case it is impossible for President, Senior Vice

President or Junior Vice President to attend Convention, can there be a legal substitute?

A.—No.

Q.—Is it proper for delegates to wear other badges than those of the W. R. C. in Convention?

A.—There is no law prohibiting other badges, so that the official badge of the W. R. C. is worn.

Q.—Can the Chairman of the Executive Committee furnish a substitute to work in her place in case of sickness or unavoidable absence?

A.—The member who comes next in rotation on the Executive Committee should perform the work of the Chairman.

Q.—Can any member in good standing be elected to an office if not present?

A.—Yes.

Q.—Do Corps have to give their Posts an itemized account of relief extended?

A.—No, but in case the Post request it, the Corps should be willing to grant the request.

Q.—Can a Corps President or any other member be exempt from dues by the consent of the Corps.

A.—No.

Mrs. Chase moved, Mrs. Harris seconded, that the report be accepted. Carried.

By request the Executive Committee of Gen. Russell Corps, No. 98, consisting of Mrs. Georgia, Mrs. Hinman, Mrs. Adams, Mrs. Hannah, Mrs. Klock and Mrs. Rogers, were escorted to platform and introduced to the Convention.

Minutes of morning session read and approved as corrected.

Mrs. Ward, of Sedan, introduced the following resolutions:

Resolution No. 1.

WHEREAS, Our retiring President, Mrs. Ida Wilson Moore, has by her admirable conduct of the affairs of the Department, evolved order from chaos and a full treasury from one bankrupt; therefore, be it

Resolved, That our thanks are due and are hereby tendered her for the efficient management of the business of the Department, and also for promptness, firmness and courtesy in presiding over the sessions of this Convention.

Resolution No. 2.

WHEREAS, We are indebted to our efficient presiding officer for the presence of the comrades of the Grand Army during the reading of the reports of the Department officers, an attendance which resulted in very flattering but merited praise of the conduct of W. R. C. business during the year, and also, as we believe, in cementing the ties which unite the Grand Army and the W. R. C.; therefore,

Resolved, That we offer our thanks to the Department President for this innovation and further, that we request her successors to extend a like invitation to the comrades at each succeeding Convention.

Moved by Mrs. Wood, seconded by Mrs. Willifred, that the resolutions be adopted. Carried by a rising vote.

Mrs. Harris moved, seconded by Mrs. Chase, that the minutes of this afternoon session be left to the out-going Council to approve. Mrs. Wickins moved to amend the motion so as to include any unfinished business. Seconded, amendment accepted and motion as amended carried.

Mrs. Lund moved that the Convention extend a vote of thanks to our efficient Assistant Secretary, Mrs. Enma B. Alrich, seconded and carried unanimously.

There being no further business, the Ninth Annual Convention of the Department of Kansas Woman's Relief Corps, was declared closed in due form.

The President reported Corps Nos. 30, 81 and 134 delinquent for over one year, although repeated efforts had been made to reinstate them, and requested the Council to take some action in the matter. Moved by Mrs. Wickins seconded by Mrs. Lapham that inasmuch as these Corps are virtually disbanded, the Council recommends that the Convention instruct the incoming President to detail competent persons residing near these Corps to visit them, and procure their supplies. Carried.

The business of this meeting is embodied in the following minutes:

ATCHISON, Feb. 27, 1892.

The new Executive Board met in Hotel Byram, Feb. 27, the following members present: Allie Myers, Chairman, M. R. Wickins, May E. Lapham and Belle Reid.

The following were appointed on the Auditing Committee: Margaret R. Wickins, May E. Lapham and Fannie H. Curry.

Belle Reid was appointed Secretary of Board.

From the report of the retiring Board we find the Department to be in debt in the sum of \$249.

After considerable planning in regard to Department work, and how to relieve the financial embarrassment of the Department, the meeting adjourned to meet at call of the Chairman.

Resolution No. 8 adopted at Convention on Feb. 26th, placing the proceedings of Convention in the hands of the Executive Board to prepare and have published, made it necessary that a meeting be called. There being many other things of importance which the Department President desired to submit to the Board for their consideration, the meeting was called at Herington, April 18, '92.

Minutes of this meeting are as follows:

HERINGTON, KAS., April 18, 1892.

The Executive Board in compliance with a call of the Chairman, Miss Myers, met at 4 o'clock, p. m., at Harvey House to examine the minutes of Department Convention and transact such other business as might come before it.

The following members were present: Miss Myers, Mrs. Wickins, Mrs. Lapham, and Mrs. Curry. Mrs. Reid not being present, Mrs. Lapham was appointed Secretary pro tem. of the Board.

The Department President being present and having several matters she desired to submit to the Board for its consideration, the Board decided to take up this business first. After some preparation and arrangements for our work we adjourned to attend a reception given to the Executive Board by Corps No. 213, of Herington, Board to meet at 9 o'clock next morning.

TUESDAY, 9 A. M.

The Department President stated to the Board that upon learning of the destructive cyclone at Towanda, she had immediately made investigation and learned that the members of the Corps at that point had suffered severe loss of property. The Secretary of the Corps was killed and Chaplain severely injured, and that she had forwarded to the President of the Corps the sum of \$35 from the Department Relief Fund.

Moved by Mrs. Wickins, seconded by Mrs. Curry, that we approve the action of the Department President in giving the \$35 from the Relief Fund for Towanda. Carried.

The case of Charlotte Ross, of Arkansas City, an army nurse who is totally blind and wishing medical treatment. The

National Army Nurse Committee having aided her to the amount of \$17, moved by Mrs. Wickius, seconded by Mrs. Curry, that the Department President have the co-operation of the Executive Board in the further expense of relief to Charlotte Ross if necessary. Carried.

The case of Christina Hyzland was presented, she desiring admission to the Madison W. R. C. Home.

Mrs. Wickins moved, Mrs. Lapham seconded, that the Department President shall correspond with railroad officials, to secure transportation if possible. Also correspond with the Dodge City Corps and ascertain if they are able to assist the Department in the expense of sending her in a comfortable manner to the home at Madison, O. Carried.

The Department President called the attention of the Board to the matter of donating \$35 from the Relief fund to the State Soldiers' Home Library fund at Dodge City and a like sum to the library of the Orphans' Home, at Atchison.

Mrs. Curry moved, Mrs. Wickins seconded, that we approve such donations. Carried.

Referring to the matter in regard to Headquarters at National Convention, Sept., 1892, after due consideration and correspondence, we, as Executive Board of Department of Kansas, believe,

First, that to postpone until later to secure Headquarters all the most desirable rooms will be taken and the poorer ones will exceed in price what good ones will be now;

Second, we have every reason to believe we will have a prosperous year and by September be able to meet the expenses of comfortable Headquarters;

Third, feeling that our Department President will do that which is for the very best interest of our Department regarding the dignity and standing as well as the financial interests, we therefore ask her to feel at liberty to secure through Commander Greene, or otherwise, as she may choose, a good, comfortable and suitable room for Headquarters.

In consideration of printing of minutes it was decided by motion, that they be placed in the hands of the Abilene Reflector for publication, a contract for the same to be presented to

the Board for their approval.

Moved by Mrs. Wickins, seconded by Mrs. Lapham, that the contract be for 1000 copies of minutes. Carried.

Adjourned for dinner.

AFTERNOON SESSION, 12:30 P. M.

Called to order by Chairman.

Minutes of morning session read and approved.

The minutes of Convention were then taken up and after thoroughly and carefully reading and preparing the same they were left in the hands of the Chairman for final copying and arrangement for publication.

A motion was then made that the expense incurred by this session be approved. Carried.

The Executive Board was entertained at the Hotel at the expense of the Herington Corps.

A vote of thanks was given the Herington Corps for their entertainment during the stay of the Executive Board in the city.

No further business, adjourned to meet at call of Chairman.

E church, invite all to the mourners' bench and sing Hallelujah. You have a lasting place in soldiers' hearts.

C., to suspension from membership in the Woman's Relief Corps, and from all the rights and privileges of the Order, except payment of dues, for the period of three years, and,

WHEREAS, The proceedings, findings, and sentence of the said Court of Inquiry in the trial of Ruth F. Durgan, were, by the Eighth Annual Convention, held at Atchison, Kansas, February, 1892, duly considered and approved; now,

Therefore, The sentence of said Court of Inquiry is hereby promulgated; and the said Ruth F. Durgan is suspended from membership in the Woman's Relief Corps, and from all rights and privileges of the Order, except payment of dues, for the period of three years from September 15, 1891.

XII. It is expected that the officers of each Corps will bring their work to the highest standard of excellence, and that each member will co-operate with them in advancing the interests, enlarging the charities, and increasing the membership of the Order. And the Department President relies upon the officers of the several Corps to carry out with promptness and fidelity, all orders from both National and Department headquarters, and earnestly urges every member to make a careful

study of Rules and Regulations and Red Book, that all work may be done with exactness.

IX. By the destructive cyclone which destroyed the city of Towanda, Butler County, on March 31st, Corps No. 201 lost all of its property, and many of the members of that Corps lost their homes and all their individual property, and are now in need of assistance. The Corps of this Department are hereby

VI. All supplies must be ordered from Department Treasurer before February 15th as the books will be closed after that date.

VII. All Corps having sent boxes to the Soldiers' or Orphans' Home will at once report the same to the Department Secretary that she may include the list in her Annual Report.

VIII. A circular giving full account of Design for World's Fair is sent to each Corps with this General Order.

IX. Aides upon the Staff of the Department President will report all duties performed by them to Mrs. Ellen M. Kimball, Manhattan, Kansas, that she may embody the same in her report.

X. The Order of Business for Convention will be the same as that used by National Convention, as far as practicable and will be found in back of Rules and Regulations and on page 179 of Red Book. The Rules of Order for the National Convention as found on pages 179, 180, 181, 182 and 183 of Red Book will be used for the government of Department Convention so far as the same are applicable.

XI. Department Officers, Delegate-at-Large, and Chief of Staff will present written reports to Department Convention. These reports should be at Headquarters by Feb. 16th. Each officer will subsequently present her own report to Convention.

Order. Corps Presidents will see that these are properly filled out. These Certificates must be presented to Credential Committee to secure badge and seat in Convention.

XV. The past year has been one of peace and prosperity to this Department, and in this my last General Order I wish to express my thanks to the more than 7,000 members of our Department who have contributed by their united and loyal support to the success of this administration.

DEAR SIR AND COMRADE:

It is with a feeling of pride that I point to the rapid advancement of the Woman's Relief Corps among the G. A. R. Posts, Department of Kansas. As your Post is as yet without this very valuable Auxiliary, a brief statistic of the wonderful growth of our Order is given:

At the beginning, nine years ago, we numbered but forty-two Corps in the Nation, we were without money, property or prestige. Today our membership is more than 140,000; our charity work over \$100,000 each year. We have a reserve fund in treasuries of the Corps throughout the land, of over \$200,000. The name of the Woman's Relief Corps has become a precious household word throughout the Republic.

OUR OBJECTS.

First—To specially aid and assist the Grand Army of the Republic, and perpetuate the memory of the heroic dead.

Second—To assist such Union Veterans as need our help and protection, and to extend needful aid to their widows and orphans.

Third—To find them homes and employment, and assure them of sympathy and friends.

HOW TO ORGANIZE.

I. The following information is given for the benefit of Posts desiring the formation of Relief Corps, auxiliary to the Grand Army of the Republic.

II. All loyal women (this means those who have not given aid or comfort to the enemies of our Union) who have attained the age of sixteen, are eligible to membership, without reference to relationship to the soldier.

III. Application for Charter must be made on regular W. R. C. blanks furnished by Department Headquarters.

IV. Applications for Charter must not have less than ten (10) signatures of women eligible to membership, and must be endorsed by the Commander of the Post applying for Charter.

V. This application duly signed and accompanied by the Charter fee, \$5.00, should be sent to Department Secretary Alice M. Seeds, Abilene, Kansas, and upon its receipt an officer will be detailed to institute the Corps and install its officers.

The following is a list of supplies necessary for organizing a Corps of fifteen members:

Forty-seven (47) cents must be added for each additional applicant to cover cost of badge and copy of Rules and Regulations.

All the above supplies except the Charter and Rituals must be procured from Department Treasurer, Frances H. Lund, Larned, Kansas. The Rituals will be forwarded from these Headquarters with the Charter.

VI. All supplies must be paid for in advance.

VII. "Only those obligated on the day the Corps is organized can become Charter members, except should any have signed the application for Charter and UNABLE to be present at organization, they may, if initiated within a month, have their names enrolled on the Charter."

VIII. All Corps must bear the name of the Post to which they are auxiliary.

IX. The membership fee shall not be less than \$1.00 with price of badge added.

X. Please read these instructions carefully and understandingly, and be assured the Department President will gladly render any further assistance or information desired.

CONCLUSION.

The Woman's Relief Corps has ceased to be an experiment. So well has it succeeded in advancing the interests of Fraternity, Charity and Loyalty, that it enjoys the unqualified endorsement of the Grand Army of the Republic.

The success of a Corps depends very largely on the character of its Charter members, and too great care cannot be taken that they may be intelligent, unselfish and patriotic that there may be able hands and zealous hearts to advance the work of the Woman's Relief Corps.

In every instance the formation of Corps has proved beneficial to Posts, resulting in increased interest taken by comrades, a wider range given your deeds of charity, social relations augmented, a general waking up all along the line.

Comrades, we earnestly desire you to take immediate steps in this good work. In case the Post Commander is too busy to interest himself we ask him to give the authority over to some patriotic woman and ask her to act for him. Correspondence solicited.

Believing each Corps will appreciate a description of the Design of our State W. R. C. to be placed in the Kansas Building at the World's Fair, this Circular is issued containing full information regarding the same.

Above all at the top of Design is our country's emblem—the eagle, from whose beak extend streamers containing the words, "Kansas Woman's Relief Corps." A picture at the top of Design is the "Firing on Ft. Sumter, emblematic of the late war, and of our Order teaching universal liberty and equal rights to all."

The picture in the scroll at the right, "Home, Sweet Home," is emblematic of the Loyalty of our soldiers, showing their sacrifice of home and happiness to defend the Nation and Liberty. The picture in the scroll at the left, "The Encampment or Reunion," is in memory of the surviving veterans—teaching a lesson of Patriotism, which is one of the principles of our Order.

In the scroll at the bottom and left is the W. R. C. badge, above it our motto and below it the words, "Protection to Our Protectors," emblematic of our Order's principal object, "Assisting the Union Veteran and the Grand Army of the Republic." In the scroll at the right and bottom is the G. A. R. badge, above it the word, "Comrade;" below it the words, "Our Honored Friends," emblematic of one of the principles of our Order, "assuring them of sympathy and friends," and representing the esteem in which they are held. At the bottom are the "Willing Hands," an emblem of the deeds of the "Army Nurses and all loyal women who rendered loving service to their country in its hour of peril." In the oval in the center is the "Soldiers' Monument," the emblem of Decoration Day, "perpetuating the memory of the heroic dead."

On each side the Stars and Stripes are hanging at half mast, and at the top is the Seal of Kansas.

This Design is to be executed on a solid piece of Kansas wood, probably three by four feet; the lettering, scrolls, etc., to be in wood carving, and the pictures to be painted in oil on the wood.

This Design was originated by Mrs. J. C. Trotter, of Wichita, and cost \$10. The whole cost of carving, material and painting will be \$150, making total cost of \$160.

The sum donated by Corps toward this Design is \$68. As this amount is insufficient and as cold winter weather prevails and many are the demands upon the Corps treasuries, in order to assist the Corps in raising the remainder of the money required, I herewith ask each member of Department Council and each Department Aide to devise some plan for at once raising \$2 each, at least, and sending same to Mrs. Frances H. Lund, Department Treasurer, for this purpose. A dime social held at a member's house to which everybody in town or vicinity is invited would soon raise the required amount. It is not necessary to wait for a Corps meeting before holding this social, as each Aide or member of Council is to consider herself a committee of one to arrange as she may deem best for the raising of money for this purpose.
