

Normally, the computation of the special year end allowance or year end adjustment of income tax are the only projects on which additional assistance may be required.

HEADQUARTERS HEADQUARTERS AND SERVICE COMMAND GENERAL HEADQUARTERS, FAR EAST COMMAND HC 240 (AG) FOR COMPLIANCE MEMORANDUM: SOLDIERS' DEPOSITS 1. It has come to the attention of this headquarters that on L occasion certain unit commanders have allowed enlisted persons to accept funds from individuals for deposit to their Soldier's Deposit account. This routine wherever practiced in this command will be discontinued forthwith. Deposits will be made in strict compliance with paragraph 2, SR 35-1550-1, SOLDIERS' or AIRMEN'S DEPOSITS, which provides that, "Deposits may be made through commanding or personnel officers to disbursing or class B agent officers." It is further provided that, "Commanders will insure that personnel under their jurisdiction are advised to make deposits only with authorized persons." 2. It has come to the further attention of this headquerters that on occasion unit commanders, personnel officers and individuals have allowed Soldiers' Deposit Books (WD AGO Form No. 14-38) to stay on file in orderly rooms and personnel offices from month to month. This routine, wherever practiced in this command will also be discentinued forthwith. In accord with provisions of paragraph 4 a referenced SR, "The deposit book will remain in possession of the depositor, except when entries are to be made therein - - - ". 3. Depositors will be advised that it is their privilege and duty to check the balance indicated in their Schlier's Deposit Book occasionally with the balance shown in the official records of the Disbursing Officer to the end that any differences may be discovered and corrected. - a. The male member is entitled to public quarters under law and Commander-in-Chief, Far East policy.
- b. Quarters assigned are commensurate with rank or grade of the male member.
 - c. Suitable married quarters are available.
- d. Parties are not precluded by distance between duty stations from living together.

The following policy statement which has been issued by the Personnel Policy Board, OSD, to the Secretaries of the Military Departments and which sets forth in detail provisions for basic allowances for quarters for all of the various combinations of marriages and dependency of members of the uniformed services, is quoted for your information and guidance. This policy has been framed to meet the legal requirements of the Career Compensation Act of 1949, the Dependents Assistance Act of 1950, and at the same time to be equitable and just to members of the Armed Forces affected. POLICY STATEMENT "1. Marriages where both parties concerned are members of the uniformed services with no other dependents and are stationed at the same or adjacent posts or installations: a. Male enlisted - female enlisted: Eligibility for assignment to married quarters, or to payment of 'single' basic allowance for quarters in lieu thereof, rests with the male member. Female member has no entitlement: (1) to married quarters, nor (2) to 'single' quarters allowance unless single quarters are not available for assignment to her. b. Male officer - female officer: Eligibility for assignment to married quarters, or to payment of 'single' basic allowance for quarters in lieu thereof, rests with the male member. Female member has no entitlement: (1) to married quarters, nor (2) to 'single' quarters allowance unless single quarters are not available for assignment to her. c. Male enlisted - female officer, or vice versa: Assignment to married quarters under these circumstances is presumed to be embarrassing to the personnel concerned and it is not considered to be in the best interest of the services. Accordingly, such assignments will not be made. In lieu thereof, certification will be provided for the male member to the effect that 'no suitable married quarters are available', and entitlement will be established for payment of 'single' basic allowance for quarters. COPY

"2. Parriages where both parties concerned are members of the uniformed services with no other dependents and where such parties are precluded by distance from living together: In such cases both parties concerned are to be considered as members without dependents.

- "3. Marriages where both parties concerned are members of the uniformed services and either or both have dependents other than spouse. In all cases, entitlement to married quarters rests with either or both and either or both may be entitled to basic allowance for quarters provided for members with dependents when not assigned quarters, depending on dependency, status of each of the members.
- "4. Marrisges where only one party is a member of the uniformed services, and there are no other dependents: With respect to female members married to civilian husbands, the law does not recognize the husband as a dependent unless he is in fact dependent upon the female member for more than one-half support. Therefore, the female member would be considered as a member without dependents for the purpose of assignment to quarters and entitlement to basic allowance for quarters unless she has established that her husband is a dependent as defined in Section 102(g) of the Career Compensation Act of 1949, as amended. Policies governing male members married to civilians are clearly established in existing regulations.
- "5. Marriages where only one party is a member of the uniformed services and such member has dependents other than spouse: . Policies governing. such cases are established and covered in existing regulations.
- "6. This policy shall include members in grades E-4 with less than seven (7) years' service; E-3, E+2 and E+1 until the termination or repeal of the Dependents Assistance Act of 1950 (April 30, 1953)."
- 2. Army Regulations No. 210-10, 12 January 1950, as amended, is being further amended accordingly.

EXECO 10204 dtd 15 Jan 51 prescribes regulations eff 1 Fcb 51 governing pmt of basic alws for qrs under Career Compensation Act. Changes affecting pmt are listed below. A. Term fld duty as used in AR 35-11,65 and TM 14-501 is changed to read: "Term fld duty shall mean svc by a member under orders with trp operating against enemy, actual or potential, or svc with trp on maneuvers, war games, fld exercises, or similar types of opn". B. Term perm sta as used in AR 35-1465, 35-4520, Til 14-501 and 14-502 for purpose of pmt of basic alws for qrs is changed to read: "Term perm sta shall mean place on shore where member is asg to duty, or home yard or home port of ship in which member is required to perform dy, under orders in ea case which do not in terms prov for termination thereof; and any sta on shore or any rec ship where member is asg and in fact occupies, with his dependents, if any, qrs under jruis of any of uniformed svc shell also be deemed during such occupancy to be his perm sta: Provided, that in case of members of MG, AMG or Res components of any of uniformed svc on AD for tng, place where tng dy is being performed shall be deemed to be perm sta of such members for purposes of these regulations", proviso quoted above changes provisions of para 5 B, AR 35-3420 to provide that tng sta is now perm sta for purpose of part of basic alws for qrs. Hence member without dependents on tng dy is not entitled to basic alws for qrs when qrs are aval at tng sta.
