1. In accordance with paragraph 3, O.D. No. 15, Hq. Eighth Army, dated 14 March 1949, the application of Masao Iwakura to travel at his expense from Japan to the Ryukyu Islands is submitted herewith.
2. The Hyogo Prefectural Welfare Department has reported that he is a practicing dentist whose income averages ¥20,000.00 monthly. He owns 70 tsubo of land and a house covering 20 tsubo of land. He maintains a standard of living which is above average.

1. In accordance with par. 3, O.D. No. 15, Hq. Eighth Army, dated 14 March 1949, the application of Fukuyasu Fukuchi to travel at his expense from Japan to the Ryukyu Islands is submitted herewith.
2. His financial support in the Ryukyu Islands as outlined in the application has been corroborated by a letter dated 23 June 1949 written by his elder brother who lives in Kagoshima. His situation in Japan as given has been verified by the Hyogo Prefectural Welfare Department. Yoshiro Kawase, physician at the Kobe Hospital of the Japan Seamen's Relief Association wrote on 27 June 1949 that Fukuyasu, Fukuchi suffered with pulmonary tuberculosis and needed three months' convalescence; this is pointed out in compliance with memorandum for the Japanese government, file AG 370.05 (7 May 1946) GC-O, SCAPIN 927, subject "Repatriation" which provided that persons with tuberculosis may be placed aboard repatriation ships provided the Supreme Commander for the Allied Powers is notified and proper surveillance is maintained enroute.
