On February 24, 1969, a Cuban national residing in Miamizwho is personally acquainted with MANUEL RAY, former Minister of Public Works in Cuba under FIDEL CASTRO, advised that MANUEL RAY is currently residing in Puerto

According to the above source, RAY arrived in Miami by plane from Puerto Rico on February 19, 1969. Upon arrival, he contacted some of his Miami associates in the Junta Revolucionaria Cubana (Cuban Revolutionary Junta) (JURE), including OSORIO DAVILA, HERIBERTO DEL PORTO, LORENZO RUIZ and LINO PEREZ (S) He requested them to confer with him at the home of Mrs. SARA ODIO, 7730 Southwest 31st Street, Miami,

He indicated he was in favor of former members of the Union Information Center (CIS), another anti-CASTRO organization, affiliating themselves with NURE. He indicated, however, that former CIS members, who are mostly students, should be most circumspect in their relations with student organizations in the United States, inasmuch as he believes communists.

RAY also indicated he welcomed the assistance of the anti-CASTRO organization Cuban Representation in Exile (RECE), which is headed by JOSE BOSCH, President of the Bacardi Corporation.
