SUBJECT: (S) Transfer Recommendation for Guantanamo Detainee, Abdul Mowla, ISN: US9PK-00442DP

- 1. (S) Personal Information: Abdul Mowla is a Pakistani national born in 1969 (age 34) in Thana Village, Malakan District, Pakistan. Detainee is blind in his right eye and has a G6PD deficiency but is otherwise in good health.
- (FOUO) Detention Information: On or about October 2001, subject detained heard a speech at a local mosque about participating in Jihad against the Northern Alliance in Afghanistan. Detainee traveled to a local bazaar, which was being used as a recruitment center. There were several thousand Pakistanis waiting for transportation into Afghanistan. They were all loaded into several hundred Datsun trucks and headed for Afghanistan. The convoy stopped for one night in Jalabad and the next night Kabul where detainee stayed in a guesthouse each time. Upon arrival at Mazar-E-Sharif, the U.S. bombing campaign against Taliban forces was in full effect and the detainee fled the area. Detainee sought refuge in an Afghan village for approximately two months and was eventually turned over to the Northern Alliance. Detainee was then handed over to U.S. forces. Detainee was subsequently transported to Guantanamo Bay Naval Base, Cuba on 11 June 2002 because of his knowledge of Taliban safe houses in Jalalabad, Kabul, and Mazar-E-Sharif. Detainee has been cooperative, but Joint Task Force Guantanamo considers the information obtained from and about him as neither valuable nor tactically exploitable.
- (S) Assessment: Based on current information, detainee ISN: US9PK-00442DP is assessed as being neither affiliated with al-Qaida nor a Taliban leader. Moreover, based on the detainee folder, the knowledgeability brief, and subsequent interrogations by JTF Guantanamo, the results of which are available on the JTF Guantanamo detainee database, the detainee has no further intelligence value to the United States and will not be seen for further intelligence purposes. Subject detainee has not expressed thoughts of violence or made threats toward the U.S. or its allies during interrogations or in the course of his detention. Based on the above, detainee does not pose a future threat to the U.S. or its interests.
