Draft revision of Regulations governing salary and allowances due Superintendent, Aomori Board of Education.

1. Superintendent of Aomori Board of Education will receive salary proper, dependent allowance and area allowance under the provisions of these Regulations.
2. Salary will be ¥18,500 per month.
3. Monthly amount of dependent allowance will be the sum of ¥500 each for wife and first-born child, ¥400 each for other eligible dependents.
4. Area allowance will be an amount equivalent to 10 percent of the sum total of salary and dependent allowance.
5. Salary and allowances will be paid in the same manner as those for other Prefectural Government workers.

By-law: The foregoing regulations will go into force as from 1 April 1949.

Bill No. 3

Revision of Regulations governing salary and allowances for Superintendent of Aomori Board of Education.

Effective from day of issue, Article 1 of the above-said Regulations will be revised as follows:

Article 1. . Superintendent of Aomori Board of Education will receive salary, allowance and over-time allowance under provisions of these Regulations.

Reason for revision: under the existing Regulations, Superintendent can not be paid for overtime work.
