It is noted that GIROLAMI besides being Democratic Ward Committeeman for the 29th Ward in Chicago is also Clerk of the Probate Court at Chicago with offices on the sixth floor of the County Building which is located across the street from the First Ward regular Democratic organization. For approximately an hour thereafter MARCY, Alderman JOHN D'ARCO, and BUDDY JACOBSON then discussed the usual affairs of the First Ward. Following this, an unknown individual who was called "BILL" by MARCY arrived and carried on the following conversation. It is possible that this individual is identical with BILL WITSMAN who is presently working very closely with Chief Investigator RICHARDACAIN as a Deputy Sheriff of Cook County. It is believed that WITSMAN and CAIN were formerly partners in a private detective agency in Chicago which corroborates the tentative identification of WITSMAN. Incidently I told you that I caught some UNKNOWN 1: fellow trying to get in here one day. MARCY:

Who's the ex-copper you got in your office?

BILL:

Oh he's OK. I got 49% of that detective agency. No I got this thing. I told that lawyer that I know that his man knows the other guy and I told him that I want him. I'll level with. MITCH EDELSON is working apparently with the bar association. Doing special work. And I think that maybe one of the ambulance chasers wanted to get into my office to find out what MITCH might have had on him. But anyway we don't want nobody here on Saturdays.

Here, do you want some more JOHN, after all this is only money. I don't want you to sit there and eat your heart out. This is only cash. (counts out money)

Following the above, D'ARCO and MARCY discussed plans for a retirement dinner for Chicago Police Captain RALPH CATANESE. They noted that GIROLAMI had taken two tables for this dinner, State Senator BERNARD NEISTEIN one, Judge PASQUALE "BUCK" SORRENTINO one table, and an unknown individual one table. It is noted that CG 6498-PC has advised that he is assisting in the organization of this dinner for CATANESE who is retiring this month and that the dinner is to be held later this month at the Chateau Royale in Chicago.

MARCY and D'ARCO then had the following conversation:

MARCY:

JOHN you got to get over this.

D ARCO:

I'm over it PAT. But I was bad there for awhile. Then when I saw what this little (obs) did, I wanted to knock his head in. But BUDDY's (JACOBSON) a goner.

MARCY:

But JOHN, you got to start getting around again. Listen when you get down in Florida you had better see LOU KOREN. Bum around with him a little bit. He's a good guy.

D'ARCO:

Does he know what happened?

MARCY:

I think he knows something happened but doesn't know just what. He asked me if we were all all right and I told him that we were.
