RE MIAMI TEL TO BUREAU DATED SEPTEMBER 9, 1978. (BUREAU EVIDENTLY NOT IN RECEIPT - IF COPY DESIRED REQUEST OF MIAMI).

SURVEILLANCE OF LARRY MACK, INC., AUTO BROKERS, 800 NORTH DIXIE HIGHWAY, REVEALED THAT THE OPERATION IS BEING RUN ALMOST SOLELY BY A WHITE MALE PROBABLY IDENTICAL WITH JAMES SCHWEIHS, SON OF FRANK SCHWEIHS. FRANK SCHWEIHS WAS NOT OBSERVED AT THE CAR LOT DURING FISURS.

ADVISED THAT SHE REMEMBERS "FRANK" AND "ANITA" AS OCCUPANTS OF APART. 409 FROM MAY, 1975 THROUGH NOVEMBER OF 1975. MRS. MICHAELS IDENTIFIED PHOTOGRAPHS OF FRANK SCHWEIHS AND ANITA SAVARD AS OCCUPANTS OF APT. 409. SCHWEIHS PAID CASH FOR THE APARTMENT AND THEY NEVER ASSOCIATED WITH THE OTHER TENANTS. MRS. MICHAELS HAS NO INFORMATION AS TO CURRENT WHEREABOUTS OF SCHWEIHS OR SAVARD.

LOS VEGAS DIVISION PROVIDED TRANSCRIPT OF TWO TELEPHONE CALLS BETWEEN SCHWEIHS AND ANTHONY SPILOTRO IN APRIL AND MAY OF 1978. IT IS BELIEVED THAT SCHWEIHS WAS IN THE COMPANY OF JOSEPH HANSEN AT MIAMI WHEN CALLS WERE PLACED. HANSEN KNOWN LOS ANGELES HIT MAN. TRANSCRIPT REVEALS CALLS MADE FROM THE "LOT" WHICH MAY REFER TO LARRY MACK, INC., AUTO BROKERS. MIAMI ATTEMPTING TO OBTAIN SUBPOENA FOR MICRO FICHE RECORDS TO SUBSTANTIATE ORIGIN OF CALLS.

SCHWEIHS HAS BEEN IDENTIFIED BY ARCHILLES AS THE MURDERER OF JOHN ROSELLI, JULY 28, 1976, AND RAY RYAN KILLED OCTOBER 18, 1977. IN MILWAUKEE TEL TO BUREAU DATED APRIL 24, 1978, SCHWEIHS WAS IMPLICATED BY HIGH LEVEL SOURCE AS MURDERER OF AUGUST MANIACI
