## 1. Reference is made to:

- a. Memorandum for Imperial Japanese Government GHQ SCAP file AG 602.5 (12 Mar 46) GD(SCAPIN - 717-A) subject: "Disposal of Land of Former Otsu Naval Training Ground School, dated 12 March 1946. (Incl #1)
- b. Ltr Shiga Military Government Team subject: Application for Release of Former Military Installation to Commanding Officer, 35th Infantry Regiment, APO 25, dated 16 August with indorsements. (Incl #2)
- c. Application chief of Shiga Ken Liaison Office for release of former military installations, dated 3 December 1946.

2. Approval of application for release of subject real estate is recommended with the exception that the commanding officer, Otsu Hydroponic Farm desires to demolish subject buildings on this land for reasons of sanitation and possible interference with objective of Hydroponic plant by having adjacent tenants who might prove to be a hazard to his mission. It is his belief that, were the materials from these buildings turned over to the prefectural authorities, adequate housing for personnel as indicated in application could be built elsewhere.

3. Inclosure No 2 indicates that all interested occupation force commanders in this area concur in the release of this area to the Japanese government.

4. Scapin 717-A dated 12 March 1946, copies of which are inclosed indicates that there may be other correspondence on this matter, not available to this organization. The land now occupied by the Hydroponic Farm was formerly called Shiga Naval Air Base (Shiga Hoku Tai) and this headquarters has no record of its prior release to the Japanese or subsequent procurement.

5. a. The area outlined in blue pencil on attached blueprint is now being utilized by the Otsu Hydroponic Farm, an Eighth Army installation.
- b. The area outlined with red crossed marks is now being utilized by the Lake Biwa Recreation Center, and I Corps installation.
- c. The area not indicated in a and b above is desired for use by the Japanese.

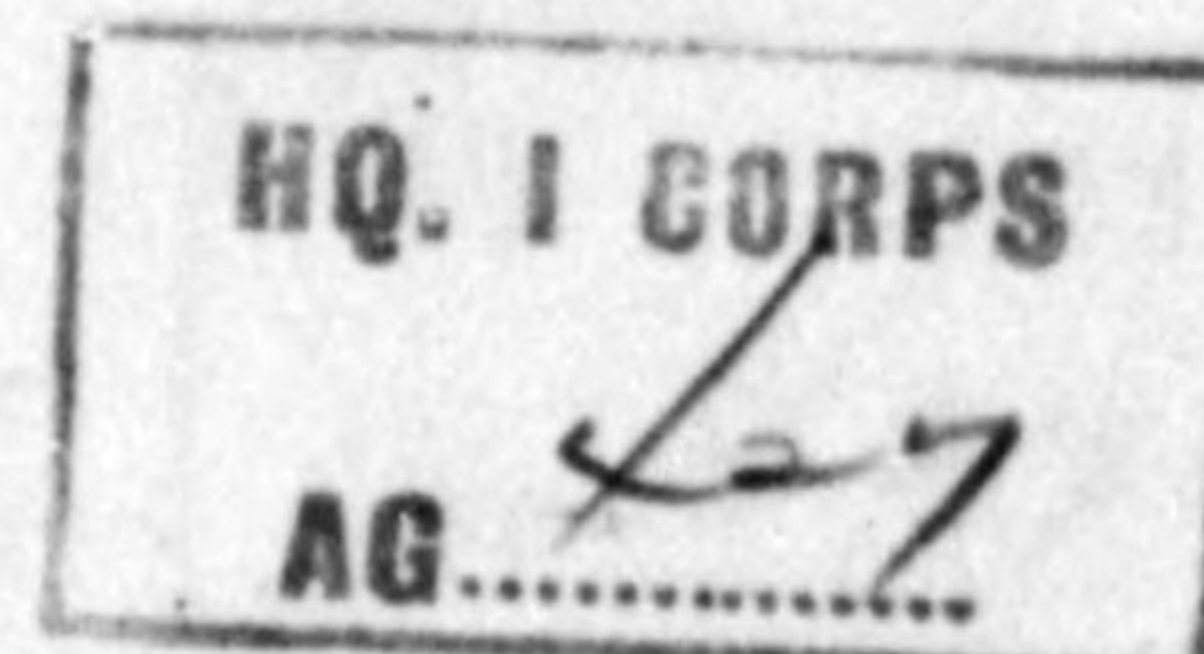
