MEMORANDUM RE: JAQUINOT (Father)

- I Subpoena subject of testimony Father JAQUINOT guided the Japanese forces when they entered the City of Hankow in October 1938 and will testify regarding the conduct of the Japanese troops there.
- II Information from the Investigation Division The Investigation Division has forwarded no information other than that found in the subpoena on this witness.
- III Examination of case file There is no reference to the witness in the case file index.
- IV Cross-reference file on case file There is no reference to this witness in the cross-index to case files.
- V Evidentiary document card file in Document Division This material has not yet been exhausted.
- VI Reference in evidence to witness or to the subject matter of his testimony This witness, insofar as I have been able to determine, is not menthoned in the record. However, Defense Document No. 958, the affidavit of OHKI, Eiichi contains a reference to this witness. It states that a group of Japanese soldiers came to the wooden fence of the Italian concession in HANKOW. "While we were hesitating as to whether or not we should advance farther, a foreign missionary, Father JAKINO, (phonetic translation) appeared and acted as a guide for the Japanese units. Since he could speak both languages, he acted as interpreter in a conversation between the Staff Officer AKAGI and the missionary."

In the testimony of A. A. Dorrance, beginning on Record page No. 3390, is a description of the actions of Japanese soldiers in Hangkow during their occupation in October 1938. Since the subject matter of this witness's testimony relates to Japanese actions in Hangkow at that time, the following excerpts are pertinent:

"At the customs wharf the Japanese collected, oh, several hundred Chinese war prisoners, or rather soldiers and I presume they were war prisoners. They were held up alongside the customs house there and picked - - well, more or less herded there.

Yangtse River the water is extremely low, and they use gangplanks that run maybe a quarter, half mile from the solid
ground out into the river. The soldiers, the Japanese soldiers,
who were at the head of this gangplank would occasionally walk
up to this crowd of Chinese soldiers -- well, Chinese people,
most of whom were soldiers according to their dress, would select
at random three or four of them and apparently with no personal
selection, just more or less point for three or four to walk on
down. Arriving at the water's edge where the water was deep,
the soldiers would kick these Chinese into the water and shoot
them when their heads appeared above the water.

"And I recall particularly in the ex-German concession, on the street corners -- oh, I saw probably six or seven on different corners -- I saw Chinese men dressed in Chinese gowns with their hands wired behind them, and they had been shot on the corner."

VII Summary of testimony given - This witness has not yet testified.

VIII - Decorations - This witness, according to our information, has not received any decorations from the Japanese Government.
