



1. No legal objections are made to subject bill.

However, since Legal Section was assigned to assist in the drafting of the monopoly legislation, it may be remarked as a matter of policy, that the value of the proposed amendment to replace "growers of leaf tobacco" by "persons who have connections with the monopoly enterprise" appears dubious. The definition of this category is very vague. The participation of producers, as previously provided, was a reasonable device. If it is the intention to include manufacturers and producers of other monopoly items as councillors of the Monopoly Enterprises Council, then this should be stated by listing them in addition to the growers of leaf tobacco. As the amendment now reads, the Minister of Finance is under no obligation to appoint a producer or manufacturer of any monopoly item and may exclude them entirely.

1. Legal Section objects to this bill because the terms "open competitive bidding" and "limited competitive bidding" are not defined by law. It is true that the provisions of Article 86 of Budget, Settlement of Accounts and Accounts Regulations (Imperial Ordinance No. 165 of 1947) ^{are} incorporated by reference, and that Sections II and III of said Regulations clarify the meaning of the terms in question. However, it is believed that said Regulations "stipulate matters of a character to be stipulated by laws" within the meaning of Article 1 of Law No. 72 of 1947 (The Law concerning the Validity of the Provisions of Orders in Force at the Time of Coming into Force of the Constitution of Japan, etc.), and will therefore cease to have validity as laws on or after 1 June 1949, unless reenacted as Diet statutes. The reference to an Imperial Ordinance which will be invalid after 1 June 1949 may well cause uncertainty and confusion. It is suggested therefore, that the pertinent provisions be integrated in the subject bill itself, or that the Imperial Ordinance as a whole be reenacted at once in the form of a Diet Law.

The bill sets up a new system for the budgets and settlement of accounts of specified Public Corporations, etc., beginning with the fiscal year 1949, which includes preparation and submission of the budget, classification of its contents, preparation and submission of reports on the settlement of accounts for each business year. It also provides that the budget shall not be used for purposes other than those prescribed by the respective items, and that transfers among the amounts of appropriations apportioned to each item prescribed by the budget of expenses may be made with the approval of the Finance Minister only when the Diet itself approved such transfers in advance in the budget itself. These provisions appear to be similar in nature to proposed amendments to the Finance Law currently sponsored by ESS.



MEMORANDUM FOR THE RECORD

SUBJECT: Amendment of the Certified Public Accountant Law

1. On March 30, in a telephone conversation between Major Harris and Dr. Fine of ESS, the above bill was cleared without any exceptions being made to its provisions.
2. Check Sheet dated 30 March, written by Mr. McKenzie and signed for General Marquat by Dr. Fine, indicated no objection to the introduction of this bill in the Diet with one exception, namely, that portion of paragraph 2 of Article 36 which amends "among Certified Public Accountants" to read: "among persons".
3. Dr. Williams phoned Dr. Fine raising the question on this difference of expressed approval of ESS. Dr. Fine stated that as far as he was concerned, the item was of no serious consequence, but suggested that it be discussed with Mr. McKenzie. Captain Guida phoned Mr. Allison, Deputy Chief, Finance Division, ESS, inviting attention to the above-stated discrepancies and the fact that the bill, as cleared by phone by Dr. Fine, had been introduced and cleared by the Finance Committee in the House of Councillors and was being considered in the Finance Committee of the House of Representatives. Insofar as this bill must be passed today, the question was raised as to whether it was imperative that a suitable correction be made at this time which would delay passage of the bill, or allow it to be passed as is. Mr. Allison expressed his regret that Dr. Fine had not cleared this bill through him and stated that it would be advisable to have the Diet pass the bill as presented, keeping in mind to have a necessary change made to the Certified Public Accountant Law at a later date.
