

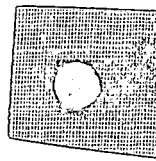
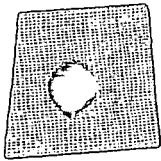

Re San Francisco radiogram and teletype to the Director, captioned matter, 10/27/61.

On 11/1/61, retired San Diego Police Department Detective LEE GRADY, a reliable San Diego source who is personally acquainted with SALVATORE BOMPENSIERO, aka Sam Bompensiero, advised that he had received reliable information that BOMPENSIERO was in San Francisco on 10/14 and 15/61. He stated that BOMPENSIERO was in San Diego and was seen daily at his downtown San Diego bars during the balance of the month of October. GRADY stated that he did not know the purpose of BOMPENSIERO's trip to San Francisco, but in the past BOMPENSIERO has made frequent trips there to visit friends and his attorney while his brother FRANK BOMPENSIERO was in California State Penitentiary. FRANK has since been released and is on parole in San Diego.

GRADY has in the past been contacted on frequent occasions concerning the whereabouts of local San Diego hoodlums including the BOMPENSIERO brothers and he was furnished no reason for the Bureau inquiry in this instance and no information whatsoever has been disseminated which could possibly prejudice informant in this case.
