Lieutenant Commander J. C. HUTCHISON, flying a photo Liberator, took off Agana Field, Guam at 0800 June 7, 1945 for photo reconnaissance of Truk. He arrived over the target at 1150 King and took vertical photographs of Moen, Eten and Param airfields and of radar installations on Pis and Tol Islands from an altitude of 20,000 ft. Heavy antiaircraft fire from Dublon and Eten was moderate and accurate but the aircraft was not hit. The plane landed at Agana at 1601 King.
