Lieut. R. W. KOBLE in a PB4Y-1P aircraft of Fleet Air Photographic Squadron One took off from Agana Airbase, Guam, M. I. on 24 July 1945 at 0740 King to photograph enemy installations on Truk Islands. He arrived over the target at 1125 King and secured good vertical photographs of Param and Moon airfields and Dublon Seaplane base all from an altitude of 18,000 feet. No enemy interception or antiaircraft fire was encountered. Lieut. KOBLE returned to Agana at 1500 King.
