- 3. In paragraphs (1) (3) (4) and (5) of Regulation 6 of the principal Regulations for the expression "chief officer" there shall be substituted the expression "divisional officer".
- 4. In the proviso to paragraph (1) of Regulation 13 of the principal Regulations for the expression "chief officer" there shall be substituted the expression "divisional officer".

Qualifications of Fire Officers

The Ministry of Home Affairs, by virtue and in exercise of the powers conferred upon it by sub-section (2) of section six of the Fire Services Act (Northern Ireland) (Reprint), 1947, as amended by the Fire Services (Amendment) Act (Northern Ireland), 1950, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Fire Services (Qualifications of Fire Officers) Regulations (Northern Ireland), 1952.

- 2. For sub-paragraph (5) of paragraph 1 of the Schedule to the principal Regulations there shall be substituted the following sub-paragraph:—
 - "(5) at the date of his appointment he is not more than forty years of age; save that a person shall not be disqualified for appointment on grounds of age alone if at the date of his appointment he is serving in a wholetime fire brigade and has so served for a continuous period of five years terminating on the date of such appointment. Provided that no person qualified as aforesaid shall, by virtue of that qualification, be eligible for appointment to a higher rank than that of Senior Company Officer under the Authority unless he has passed a further technical examination of a standard approved by the Ministry."
