B Status quo of the enterprise

The Company has paid no dividend yet since its establishment, and the documents were burnt up owing to war disaster, with the result that the gains of the Company during the war remain uncertain. The latest balance sheet (for the 22nd term) estimates the loss at 309,865 yen 63 sen.

The items of Nakajima Enterprise Account and Loan Account amounting to 2,688,666 yen 94 sen, which may arouse the suspicion of concealment of profits, if any, are as follows:

Loan resulting from the selling of the smelting works to the Nakajima family from the Company	yen 1,495,179.22
Loan for the payment of the interest upon the funds borrowed by the Nakajima family from others	45,000.-
Interest on the loan for the Nakajima family by the Company	170,000.-
Loan to cover the mine-lot tax with its surtax, lawsuit expenses, etc.	78,000.-
Loan to cover the instalments on the debt to the Kinki Mutual Financing Company as well as the interest on the debt to Mr. KONDŌ	900,000.-

NEARLY 800 SMALL CONCNS. SPRING UP
IN PLACE OF DISBANDED ZAIBATSUS

TOKYO, November 9--Small new business companies have mushroomed in the wake of disbanded big zaibatsu concerns.

A Metropolitan Police Board survey disclosed that the number of new companies set up by former employes of Mitsui and Mitsubishi affiliates has reached 231.

The number is estimated to add up to nearly 800 throughout the nation, when the employes of other zaibatsu companies are taken into account.

Their businesses cover textiles, foodstuffs, timbers and other supposedly lucrative ones, but, without exception, financial difficulties stand in the way of their development.


The police survey revealed that increasing number of them have found themselves implicated in black market transactions to obtain funds required for their operation.


