FEC-242/32 is a proposed policy decision approved by the Steering Committee on 18 May 1948. The Australian, Canadian, French, Indian, Netherlands, N.Z., Philippine, and U.K. delegations have been recorded as approving the proposal. On 12 May 1949 a comprehensive U.S. statement, including views on the subject, was presented (see FEC-340). On 6 October 1949 the Soviet representative submitted a statement (FEC-242/42) summarizing the Soviet position and urging that the proposed policy decision and the Soviet amendments in FEC-242/37 be discussed. He renewed this suggestion on 8 December.

FEC-371 is a proposed policy decision submitted by the United States representative at the 184th meeting, 23 February 1950. Brief comments of a preliminary nature occurred at that time, with the French and U.K. representatives indicating concern as to the sovereignty aspects of the proposal. On 2 March the U.S. representative offered comments in further clarification of the views of his Government. The Australian representative indicated opposition on the part of his Government to the proposal. With regard to procedure, it was agreed that the proposal would be retained on the Commission agenda until representatives had had an opportunity to submit comments of a general nature. The Burmese, French, Indian, Netherlands, Philippines, and U.K. representatives remarked that they were without instructions.

ITEM 3 - JAPANESE MEMBERSHIP IN INTERNATIONAL CONVENTION OF TELECOMMUNICATIONS (FEC-334, /1, /2, /3, /4, /5, /6, /7)

A U.S. reply to this Soviet statement was submitted on 17 November 1949 (FEC-318/30). Further Soviet comments and U.S. remarks in reply are recorded (pp. 4-7) in the minutes of the 178th meeting.

A U.S. reply to this Soviet statement was submitted on 17 November 1949 (FEC-318/30). Further Soviet comments and U.S. remarks in reply are recorded (pp. 4-7) in the minutes of the 178th meeting.

ITEM 6 - REPORT OF COMMITTEE NO. 1 TO THE FAR EASTERN COMMISSION REGARDING DIVISION OF REPARATIONS SHARES (FEC-219/25, 219 series)

FEC-219/25 is a report by Committee No. 1: Reparations, on the status of negotiations concerning the division of shares of industrial facilities within Japan declared available for reparations. The comprehensive U.S. statement of 12 May 1949 (FEC-340) bears on this subject.

ITEM 7 - a LEVEL OF ECONOMIC LIFE IN JAPAN: POLICY TOWARDS JAPANESE INDUSTRY
(FEC-242/32; /35, /37, /38, /39, /40, /41, /42)

FEC-242/32 is a proposed policy decision approved by the Steering Committee on 18 May 1948. The Australian, Canadian, French, Indian, Netherlands, N.Z., Philippine, and U.K. delegations have been recorded as approving the proposal. On 12 May 1949, a comprehensive U.S. statement, including views on the subject, was presented (see FEC-340). On 6 October 1949 the Soviet representative submitted a statement (FEC-242/42) summarizing the Soviet position and urging that the proposed policy decision and the Soviet amendments in FEC-242/37 be discussed. He renewed this suggestion on 8 December.

- b LEVEL OF ECONOMIC LIFE IN JAPAN: POLICY TOWARDS SHIPBUILDING AND SHIPPING (FEC-297/10)

FEC-297/10 is a proposed policy decision forwarded without recommendation.

ITEM 8 - JAPANESE REPARATIONS AND LEVEL OF INDUSTRY (FEC-340, /1, /2, /3, /4, /5, /6, /7, /8)

FEC-340 is a comprehensive statement on the subject of reparations and level of industry, submitted by the U.S. representative on 12 May 1949. The Chinese, Philippine, and N.Z. delegations are opposed to the U.S. position (see (FEC-340/1-6, inclusive). The Indian delegation favors the U.S. view (see FEC-340/8). No formal views have been expressed by the Australian, Canadian, French, Netherlands, USSR, and U.K. delegations.

ITEM 9 - REPARATIONS REMOVALS: ACCESSORY FACILITIES, BUILDINGS, TECHNICAL DATA
(FEC-299/5; /6, /7, /8, /9, /10)

Three outstanding papers are awaiting action on this subject:

1. FEC-299/5 - a proposed policy decision approved by the Steering Committee on 20 July 1948 by 7 to 3 (Canada, U.K., U.S.), with 1 abstention (Australia).
2. FEC-299/8 - a Netherlands substitute proposal, consisting of FEC-299/5, less paragraph 2.
3. FEC-299/9 - a Chinese proposed amendment to paragraph 2.

The U.S. position has been reserved on this item. The comprehensive U.S. statement of 12 May 1949 (FEC-340) bears on this subject.

ITEM 10- ECONOMIC STABILIZATION IN JAPAN

On 24 February 1949 the Commission agreed to retain this subject on its agenda, while referring the various papers in the 329 series as well as the view expressed up to that time to Committee No. 2: Economic and Financial Affairs. The only action at the Commission level since the reference to Committee No. 2 has been a statement submitted by the Soviet representative on 3 March 1949 (P. 2, Minutes, 143rd FEC Mtg.).
