In view of the present situation in and around the walled city of Mukden, the Commander of the Japanese Army on Sept 20 1931 will place said area under the temporary city administration of Japanese and Chinese acting under the army in order to promote the welfare of both Japanese and Chinese inhabitants.
- 1. The Mukden city administration area will be limited within the walled city of Mukden and its foreign settlement quarter. The South Manchurian Railway zone will remain as before.
- 1. The City administration business will be conducted at the Municipal Building which will be set up in the main street of Hsiao Hsi M in the walled city.
- 1. The city administration business will include all matters con cerning Mukden City except for cases otherwise provided for.
