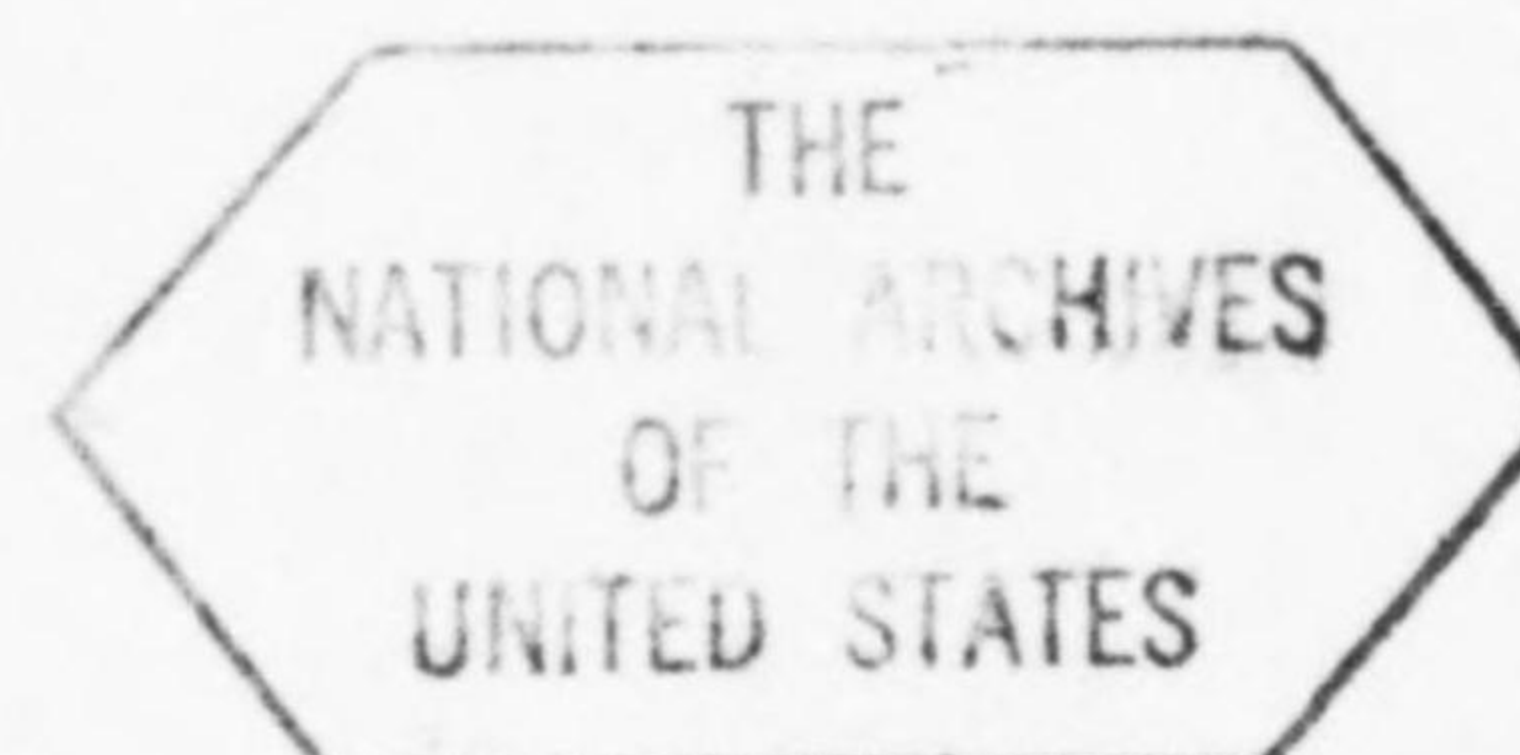

PLANNED ACTIVITIES OF MIYAGI-KEN SOCIAL WORK
ASSOCIATION FOR THE YEAR OF 1950.

Submitted by Mr. Imaoka

1. Orientation Course for Social Worker.

- 1) General Lecture:
To hold Lecture Course on Social Work in general for about three months for new appointee and supervisor.
- 2) Professional Short Period Lecture Course:
To hold Short Period Lecture Course in Sendai and each district differently by classification of Social Work.
For instance: Lecture Course on Case Work, for M.I., on Group Work ~~and~~ for operators of the institutions concerned, etc.
- 3) Supervisor's Regular Study Conference:
To hold, differently by classification of Case Work, Supervision, and direction (Administration in general), Group Work, and so forth, Regular Study Conference of Supervisors and the persons concerned in order to compile essential materials for guidance and instruction.
- 4) Round-Table-Conference regarding Social Work Education
Its member shall be consist of representatives of every Governmental and Civil Circles and have the periodical conference in which they shall find the necessities of education for Social Work and devise the opportunities to fulfill such necessities in an effort to combine both in order to make the consolidated plan of Social Work Education, together with inquiry on the results of practice of said plan.
- 5) Social Work Education for Student in general:
To encourage University Authorities and other school authorities to provide a lecture course regarding Social Work and try to give students Lecture or materials necessary regarding Social Work at every opportunity.
- 6) Education for Prefectural People:
To make, by taking an advantage of every opportunity, an occasion available for Lecture Meeting, Display of materials concerned and cooperative service for the purpose to deepen people's understanding toward Social Work.
- 7) To make a plan to let the excellent one selected from among Social Workers have an inspection trip on the superior social work institutions in and out the pref. or the one in Tokyo.

Also, in order to provide for said inspection trip, to make a list of superior institutions throughout the country.

- 8) Encouragement of Professional Social Work Education:
To encourage the social worker and common people to enter Japan Social Work College by providing a scholarship system.

- 9) Guidance by Publications:

To compile a list of excellent reference books separately by kinds of Social Work and carry out introduction of main books as well as make an effort to establish a Library within the Social Work Association Hall for not only utilization of Sendai city but also of every area of the Prefecture.

By keeping a close contact with the Pref. authority and School Libraries, to make an effort to provide as many books regarding Social Work as possible.

To make publicity of C.I.E. Library so that more people in general will come to utilize Social Work books stored therein.

By keeping a close contact with Japan Social Work Association or the Publishers and Book-sellers, to give a convenience to the persons concerned so that they can promptly obtain the excellent books.

- 10) Matters relating to Publications:

- A) By issuing a seasonal of Social Work Research 4 times a year, to make it public the results of research of Social Work Research Society and other results of various services and researches, and at the same time, use them as the texts of In-Service-Training.

- B) Issue of Texts and other Printings:
Issue of the texts regarding Social Work in general and techniques. In addition, to issue the necessary printings regarding Social Work as occasion calls.

- C) By issuing a monthly of Social Work, to make it public the informations and reference materials obtained of every direction of Social Work.

- 11) Others: By taking an advantage of every occasions available, to make an effort for educational training of the persons in service.

2. Survey & Research on Social Work:

For the purpose to promote positive activities of Social Work in order to contribute toward welfare of the society or promote education of the persons in service, scientific survey of various social condition, study of the measures possible, adaption of Social Work Literature of the advanced foreign countries and other study of various social sciences shall be conducted.

1) The following matters shall be conducted as a survey on an actual conditions:

A)

a) To carry out continually the 5 Years Program of the Survey on an actual situation of MIYAGI Ken Social work.

b) Social Survey on an urban district, agricultural, mountain, fishing villages.

B) Survey on living situation of the household under Public Assistance.

C) Survey on widow and special women.

D) Other Surveys necessary.

2) Study:

A) By selecting the Study committees from the persons of scholar or experience in every direction of circles concerned and let them study jointly or individually on the following subjects:

1. Idea and characteristic of the modern social work.

2. Family system and Social Work.

3. Theory and practice of case-work.

4. Fundamental problem of Administration of Social Work.

5. Introduction of Foreign Country's Social Work into Japan.

6. Characteristic of MIYAGI Ken Social Work.

7. History of MIYAGI Ken social work.

B) To hold, as occasion calls, a Meeting consisting of the workers of various social works.

C) Establishment of Miyagi Branch of Social Work Research Society.

D) To hold a Meeting for an announcement of the research on social work.

Under a close contact with the same announcement meeting which being held once a year in Tokyo or the general meeting of the Study Society, to hold such meeting on the occasion of General Meeting of the Pref. Social Work in order to develop and enhance the work.

3. Promotion of Social Work.

1) Commendation of superior social institution and outstanding social worker.

- 2) Assistance to Day Nursery during farmer's busy season.
Technical guidance as well as monetary assistance.
- 3) To encourage establishment of Settlement Association on a level of towns and villages, and strengthen the lower organization of Social Work, and, especially with the preceding paragraph, promote Social Work in agricultural community and make an effort for return of Community Chest Fund to local district.
- 4) Encouragement of protection of physically handicapped person.
To encourage and promote the institutions for protection of physically handicapped person or T.B. sufferer.
- 5) Finance to Social Work:
The loan with low interest to Social Work Institutions.
- 6) To establish within the Social Work Association Hall the consultation board which shall comply with consultations regarding operation and minimum standard of social work institutions, problems in every direction of social work, legal problem and social problem in general, and set up measures considered as adequate.

4. Coordination and systematization of Social Work.

- 1) To hold Meeting of Social Welfare Council:
To establish the Council consisting of the persons concerned in governmental and private social work, and the Council shall have periodical meeting and try to contact and coordinate the activities among various social works together with promote social welfare.
- 2) The Council shall, as one of its projects, take a part of pro-peller in the drive of " Children's Day ", " Mother's Day " and " Love Movement " which is for relief of repatriates, and etc.
- 3) To hold Round-Table-Conference of Operators of Social Work Institutions.
- 4) To hold Meeting of Social Work Association.
To hold once a year the Meeting of the persons concerned in social work in the Pref.
- 5) To organize Volunteer Cooperative Organization of Social Work in an effort to promote social work of the Pref.
- 6) Social Worker:
To provide an occasion for mutual training and friendship for the purpose to enhance personality and welfare of social worker.

In order to achieve such purpose and as a fundamental material of various policies such as mutual contact and cooperation;

to make name list of social work institutions and its staffs.

- 7) Table showing present situation of social work.
To make such table in order to grasp always and clearly
the present situation of social work institutions.
