The following articles are added:
Article VI
The purposes for which this organization is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section $501(\mathrm{c})(3)$ of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

## Article VII

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

## Article VIII
