Frequently Asked Questions:

Q. Where can I find the organization's Employer Identification Number (EIN)?

The easiest way to obtain the EIN number is to call the organization directly. You may also choose to obtain it yourself by using the on-line tool called **Guidestar** <http://www.guidestar.org>

Q. Is my donation eligible for a double match?

The double match option is no longer available, but your gift is eligible to be matched dollar for dollar. This is a great way to continue to support NikeGO, Nike's long-term commitment to get kids moving.

Q. Is my child's school eligible?

Your child's school will be eligible if the school is accredited by an approved nationally recognized accrediting agency or classified as a public school. Check with your child's school for this information.

Q. Can I donate money to my church?

A church, just as other tax-exempt organizations, will be eligible as long as it meets the program guidelines.

Q. Is there a maximum donation amount?

As an employee you may give as much as you choose; but remember the maximum amount matched through the Employee charitable Giving Program, Matching Gift Program and Volunteer Hours Match Program is combined total of \$5,000 per fiscal year.

Q. Is my donation a pre-tax income deduction?

No, your donation through payroll deduction will be deducted on an after-tax basis.

Q. Can I make donations that are both one time and ongoing?

Donations through payroll deduction must be either one-time or ongoing.

Q. When will my organization(s) receive funds?

Confirmed organizations will receive five checks; one per quarter and one matching gift check in June.

Q. How will I know if my donation registration has been received?

In most cases, you will receive confirmation via email or by U.S. Mail. If in doubt, please email nike@easymatch.com or call 1-888-671-4438.
