1. HONG KONG - The Secretariat adheres presenting the annual of the Provisional Directory reports for the period between 1 July, 2008 and 11 July, 2009, and the audited Financial Statements for the period between 1 July, 2008 and 30 June, 2009 for Wikimedia Hong Kong (and in this report it is referred as **the Chapter**).

GOVERNANCE

2. In last year, the chapter had experienced the transition from the provisional model to a democratic middle-stage governance system. Through the Meeting of the Members election in the 2nd General Assembly, we selected the first democratically elected Directory, which took office in the next fiscal year covered in this report.

1ST MEMBERS ASSEMBLY

3. The First Annual Members Assembly was held on 7 March 2009, in New Asia College, CUHK, with an attendance of 58%. Rules of Meeting Procedures, Bylaws for the Directory & Articles to suspend forming the Council of Wikimedia Hong Kong had been passed by the members attended the meeting. The members also accepted the reports of previous years. The Provisional Directory was also granted the right to continue commissioning the current audit service.

2ND GENERAL ASSEMBLY

4. The Second Members Assembly (Special) was held on 4 July 2009, in Chung Chi College, CUHK, with an attendance of 50%. The amendments to the *Bylaws for the Directory* had been passed by the members attended the meeting. The members also elected the first Directory in the meeting. The members listed below were elected as Directors, & they swore in to office a week later.

8. No contract of significance, to which the chapter was a party and in which a Provisional Director had a material interest, subsisted at the end of the year or at any time during the year.

FINANCE

22. Similar to the Wikimedia Foundation, Donation is the main source of the income of the chapter. In year the Chapter received 4200 Hong Kong Dollars as donations in total.

BANK ACCOUNT

23. The Provisional Directory decided to set up a Hong Kong Dollar saving account and a Hong Kong Dollar cheque account in Chong Hing Bank on 25 March 2009, and they started functioning on 22 May 2009 (Cheque account) and 6 June 2009 (Saving account).

DEVELOPMENT FUND

24. The Development Fund of the chapter had accumulated, according to the relevant sections of the Articles of Association, to 700 Hong Kong Dollars in total.

AUDITOR

25. According to the relevant resolution in the 1st Annual General Assembly, FCCL & Co. was designated as the auditor for the Chapter.

26. Unless there is another resolution passed by the Members Assembly or the Directory, FCCL & Co. will continually be commissioned as the auditor for the Chapter.

OUTREACH

ANNIVERSARY CONFERENCES

- 27. Last year, we started a tradition of hosting an anniversary conference a year. The first one was host on 12 July 2008, which was a panel between the chapter members and the professionals in the education professionals, who provided crucial idea for the chapter to develop educational programs in the future.
- 28. In the end of the administration year 2008/09, we also planned for an anniversary conference second time in July, to combine the event with the an event of 3C series by Internet Society Hong Kong, Creative Commons Hong Kong, dot Asia Organization & Hong Kong Internet Service Provider Association, which was also planned in July.

RELATION WITH COUNTERPARTS

- 29. The Chapter started to support and co-host events with some local counterparts, including sending volunteers to support the start-up process of the Creative Commons Hong Kong, and co-host the talk Web 2.0 & Free Culture Benefits and Opportunities with Student Society of Computing (Full-time program), the Open University of Hong Kong.
- 30. In December 2008, we also collaborated with local volunteers for Creative Commons, to help a Wikipedian to get compensated from the agency who had created an advertisement using his image, without complying the obligation of the Creative Commons License. The case was settled peacefully. In addition, the Chapter along with Creative Commons Hong Kong was awarded a chance to introduce the License and things need to concern while reusing materials on Wikimedia.

CHINESE WIKIMEDIA CONFERENCE 2009

31. The Provisional Directory had express the fully support to the Macau community who bided for the Chinese Wikimedia Conference 2009. As the results, a task force to support the event was formed as described in the previous paragraphs.

We have audited the financial statements of Wikimedia Hong Kong Limited set out on pages 3 to 8, which comprise the balance sheet as at 30 June 2009, the income statement, the statement of changes in equity and the cash flow statement for the year then ended, and a summary of significant accounting policies and other explanatory notes.

Director's responsibilities for the financial statements

The director is responsible for the preparation and presentation of these financial statements in accordance with the Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants and the Hong Kong Companies Ordinance. Except as described in the basis for qualified opinion, we conducted our audit in accordance with Hong Kong Standards on Auditing issued by the Hong Kong Institute of Certified Public Accountants. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance as to whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and true and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. - The entire company's recorded income (HK\$5,450) was cash receipt, over which there was no sufficient evidence which we would rely for the purpose of our audit. There were no other satisfactory audit procedure that we could adopt to satisfy ourselves that the recorded turnover was free from material misstatements.

Qualified opinion arising from limitation of audit scope

In our opinion, except for the effect of such adjustment, if any, as might have been determine to be necessary had we been able to satisfy ourselves as to income, the financial statements gives a true and fair view of the state of the company's affairs as at 30 June 2009 and of its surplus and cash flow for the year then ended in accordance with Hong Kong Financial Reporting Standards.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2009

(Expressed in Hong Kong dollars)

LEGAL STATUS

The company was incorporated in Hong Kong with limited by guarantee under the Companies Ordinance Chapter 32. The registered office of the company is located at 3/F, 187E Hai Tan Street, San Shui Po, Kowloon.

The principal activity of the company was engaged in promoting and understanding the meaning of Wikimedia.

2. STATEMENT OF COMPLIANCE

The financial statements have been prepared in accordance with accounting principles generally accepted in Hong Kong, that include Hong Kong Financial Reporting Standards (HKFRSs) and the requirements of the Hong Kong Companies Ordinance. A summary of changes in accounting policies resulting from the company's application of these HKFRSs is set out in note 3 and a summary of significant accounting policies is set out in note 4.

APPLICATION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS (HKFRSs)

In the current year, the company has applied a number of new standard, amendments and interpretations issued by the Hong Kong Institute of Certified Public Accountants (the HKICPA), which are effective for accounting periods beginning or after 01 July 2008.

The company has not early applied the relevant new and revised standards, amendments or interpretations that have been issued but not yet effective. The directors aniticipate that the application of thesse following revised standards will have no material impact on the results and the financial position of the company

4. SIGNIFICANT ACCOUNTING POLICIES

a) Capital levy

The capital levy is an equity contribution from members and is taken to the development fund directly in the year of receipt.

Revenue recognition

Members' subscriptions and donation received are accounted for on actual receipt basis.

c) Related party

Parties are considered to be related if one party has the ability, directly or indirectly, to control or exercise significant influence over the other party in making financial and operating decisions. Parties are also considered to be related if they are subject to common control or common significant influence.

d) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term liquid investments that are readily convertible into known amouns of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity of acquisition.

CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENT

The company's management makes assumptions, estimates and judgements in the process of applying policies that affect the assets, liabilities, income and expenses in the financial statements prepared in accordance with HKFRSs. The assumptions, estimates and judgements are based on historical experience and other factors that are belived to be reasonable under the circumstances. While the management reviews their judgements, estimates and assumptions continuously, the actual results may differ from these estimates. However, the directors are of the opinion that no critical accounting estimates and judgement was involved for the period.

FINANCIAL RISK MANAGEMENT

The company is exposed to various kinds of risks in its operation and financial instruments. The company's risk management objectives and policies mainly focus on minimizing the potential adverse effect of these risks on the company by closing monitoring the individual exposure as follows:-

Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash to meet its current and expected liquidity requirements in short and logn term. The company's liquidity need are mainly financed by the directors' advancement.

ii) Capital management

The company's objective when managing capital is to safeguard its ability to continue as a going concern, so that is can continue to provide services in order to meet the company's objectives. The company manages capital by regularly monitoring its current and expected liquidity requirements rather than using debt/equity ratio analysis.

Instead of increasing its capital fund by donation from the members, the company's operation is mainly sourced from directors' advancement. The company is not subject to either internally and externally imposed capital requirements. The current rate of capital levy is HK\$20 per member.

8. TAXATION

Provision for Hong Kong Profits Tax is not required as the company has exempted under Section 88 of the Inland Revenue Ordinance.
